Re: Complaint against Justice Matthew F. Cooper (Supreme Court New York County)

Dear Sir or Madam:

I write to file a third formal complaint against Justice Matthew F. Cooper of the New York County Supreme Court for yet another troubling incident that took place on November 2, 2016.

At approximately 9:25 a.m. on November 2, 2016, Justice Cooper physically assaulted and harassed me on the corner of Rector St. and Broadway (mere steps away from the Commission's office) while I was walking south on Broadway. Justice Cooper initiated and instigated a physical confrontation that cumulated in Justice Cooper spitting on me. He then fled to the subway station at Wall Street. I am in possession of photographic and video evidence that corroborate these events. These photographs and videos have been shared with police authorities. I can provide them to the Commission upon request.

Immediately after the incident, I notified the New York Police Department ("NYPD"). The NYPD filed a report against Justice Cooper for assault and harassment. A copy of the police report is attached hereto.

As this Commission is aware, Justice Cooper has a documented pattern of engaging in disconcerting and disreputable conduct towards me, including making threats of physical harm against me. In my July 27, 2016 complaint filed with the Commission, which is still pending, I referred the Commission to instances where Justice Cooper challenged me to physically "rumble" with him during the custody and access trial in *Zappin v. Comfort*. Likewise, during the trial, Justice Cooper slammed his fist at me in an attempt to intimidate me, threw papers in my direction and engaged in a litany of other disturbing conduct, including making wholly inappropriate and threatening statements. All this conduct is explained in detail in my July 27, 2016 complaint.

I would appreciate the Commission investigating this matter further. Justice Cooper's behavior yet again raises serious questions about his temperament and fitness to sit on the bench. No litigant should be placed in a position where he is physically assaulted or fears for his safety while in the presence of a judicial officer.
