Dear Professor Zimmerman,

Thank you, genuinely, for your return call – and your willingness to examine the constitutional arguments we have made to the Governor & Legislature with respect to the Legislature's proposed budget and that of the Judiciary.

Let's start with the Legislature's proposed budget for fiscal year 2014-2015 – which is <u>not</u> certified and is <u>not</u> represented as being "itemized estimates" of the Legislature's "financial needs". This is the subject of our December 30th letter to Governor Cuomo, which argues that such proposed budget does not satisfy the <u>conditions precedent</u> of Article VII, Sec. 1 for inclusion in the state budget.
