Following up our phone conversation a short while ago, please read the two letters I left for you on November 29th, each setting forth research proposals for scholarship on the New York State Constitution and governance –the necessity of which is established by the Verified Complaint & exhibits in our People's lawsuit vs New York's highest constitutional officers, contained in the box I also left for you.

If the Rockefeller Institute of Government at SUNY-Albany has NOT a single scholar of the New York State Constitution and governance to whom you can direct the research proposals and primary-source evidence I furnished, then maybe that explains why our state is in such DIRE straits. Surely, the family of Governor Rockefeller would fund the kind of essential scholarship whose necessity those letters describe.

I will call you IMMEDIATELY after the New Year, if I do not hear from you before then.
