Please forward to the "designated Ethics Advisor" my above-attached October 16, 2021 letter to U.S. Attorney Williams – and the above-attached superseding October 13, 2021 letter, which REPLACES what I sent you last Wednesday and Friday by the below e-mails, which you presumably forwarded.

Please note that the posted October 13, 2021 – which is the above-attached – makes a minor addition to the October 13, 2021 letter mailed with my October 16, 2021 letter. The addition is at page 6, footnote 7, where the first sentence of its second paragraph is now expanded with the words "pursuant to correspondence between them ([April 3, 2014](#), [April 9, 2014](#), [April 10, 2014](#)),".

The full sentence now reads:

"The 'potential crime' was fraud by the Commission to Investigate Public Corruption by selective and incomplete turn-over of its records to U.S. Attorney Bharara – because were the Commission to make full turnover, pursuant to correspondence between them ([April 3, 2014](#), [April 9, 2014](#), [April 10, 2014](#)), such would reveal its corruption – the same as was particularized by [my April 23, 2014 order to show cause to intervene in the Legislature's declaratory judgment action against the Commission to Investigate Public Corruption](#) and reflected by the [citizen-taxpayer action I had commenced on March 30, 2014](#)."

I have not, as yet, received a call or e-mail communication from the "designated Ethics Advisor" and would appreciate if you would forward to him/her this e-mail, attaching a corrected October 13, 2021 letter, which makes substantive changes and elaborations to the original letter, prompted by my discovery, as I was preparing to print and mail it, that I had received 4, not 3 acknowledgment letters from U.S. Attorney Bharara – [the last dated April 30, 2014](#).

I have already posted this superseding October 13th letter on CJA's website, on the below indicated webpage – and signed originals are already in sealed envelopes that I will be mailing shortly.

In the event the "designated Ethics Advisor" is not planning to call me to discuss the letter and the further conflicts of interest arising from U.S. Attorney Williams's October 13th appointment of Margaret Garnett as his deputy, not included in the letter – I ask that he/she authorize you to furnish me with his/her name so that I will know that there is, in fact, such a "designated Ethics Advisor" in the office, but that he/she will not speak with me.
