GOVERNOR PATAKI ANNOUNCES MEMBERS OF THE STATE JUDICIAL SCREENING COMMITTEE, MAKES THREE JUDICIAL APPOINTMENTS

Governor George E. Pataki today amounced the membership of the State Judicial Screening Committee, ensuring only the highest caliber candidates are recommended to become judges of the Court of Claims.

In addition, Governor Pataki announced the designation of Nicholas Colabells as an Additional Justice to the Appellate Division of the First Department. The Governor also nominated Mark C. Dillon to serve on an interim basis as Judge of the Westchester County Court, and Russell P. Buscaglia as Judge of the Court of Claims, which will require Sense Confirmation. These individuals were previously screened and found highly qualified by the Temporary Judicial Sereening Committee.

"The State Judicial Screening Committee will ensure that the highest quality appointments will be made." Governor Pataki said. "Becisions by our courts in criminal and civil cases have profound consequences for all New Yorkers, and we need to have confidence in the integrity of the judicial process."

The 13-member committee consists of the Counsel to the Governor, the Champerson of each of the four Departmental Judicial Screening Committees and two members of each of the four Departmental Judicial Screening Committees.

The Covernor has appointed the following individuals:

Michael Finnegan, Counsel to the Governor, will serve as the Chairman of the committee.

James F. Gill, of Rockville Centre, who is the designee of the Governor as Chairman of the First Department's Departmental Judicial Screening Committee, has been engaged in the practice of law since 1956 and is a managing partner in the law firm of Robinson Silverman Pearce Aronsohn & Berman LLP. Mr. Gill served as a member of Mayor Koch's Judicial Screening Committee from
