If you make the complaints your campaign issue, you will win – EASILY and without money. As a candidate, you have a "bully pulpit". Stand up for honest and accountable government: publicly call on Assemblyman Tague to respond to the complaints – which I furnished him-- publicly call upon the seven district attorneys to explain why they have not presented the complaints to the grand juries of their counties, and publicly call upon the press to do its part and investigate and report.
