TO: St. Joseph's Collegiate Institute Annual Political Debate Director Juliana Wright

Thank you for your call back – and the time you gave to our conversation. As discussed, I learned of your October 24th debate between D.A. Candidates Keane and Gardner from today's WBEN article "Zeroing in on race for Erie County District Attorney" by Brayton Wilson.

Below is my e-mail to Buffalo's WBEN Radio that I was just about to send when you called me – and which I partially read to you. Beneath it are my e-mails to Buffalo's Channel 7 News and Channel 2 News – and beneath them my first e-mails to D.A. Candidates Keane and Gardner, respectively, on July 18th and July 24th. All attached the above-three items.

The July 24th e-mail, which was to Candidate Gardner, stated:

"Last week, I sent Acting D.A. Keane – and all 61 of New York's other D.A.s and acting D.A.s – the above three attachments by the below July 18th e-mail entitled 'NOTICE & grand jury/public corruption complaint – Your D.A. salary increases, the judicial salary increases on which they are based, & the violations of NY penal laws by state legislators within your jurisdictions', requesting their answers, by August 1st, to two simple questions:

- (1) whether they will be repudiating their state-mandated D.A. salary increases, paid from their county budgets, because they are based on three "false instrument", penal law-violating commission reports raising judicial salaries;
- (2) confirmation that they will be recusing themselves from CJA's July 18, 2024 grand jury/public corruption complaint pertaining thereto and securing an independent prosecutor.

If elected, what would your answers be? Please let me hear from you by August 1st so that, based on your answers, Erie county voters may be apprised as to whether a write-in campaign must be launched for suitable D.A. candidates who will abide by their duty of enforcing New York's penal

laws, without fear or favor, including by recusing themselves when compromised by self-interest and relationships."

I received no response from Candidate Gardner to this e-mail, just as, likewise, none from Acting D.A. Candidate Keane to my July 18th e-mail. Thereafter, I cc'd them on three essentially-identical August 8th e-mails to the Buffalo News, to WBFO, and to Investigative Post, followed by a more extensive August 28th e-mail to Spectrum News, to which they were also both cc'd. All these e-mails reiterated the above two questions – which I am now requesting that the students of St. Joseph's Collegiate Institute examine and ask D.A. Candidates Keane and Gardner at the debate.

Here's CJA's webpage for the Erie County D.A. race, on which everything is posted – and which includes a helpful "Guide for Erie County 'Local Journalism'", further explicating the situation. Perhaps you have some aspiring political journalists among your students?

Please forward to <u>Social Studies Teachers Theodore Lina and Patrick McHale</u>, as you said you would, with my sincerest thanks for their spectacular contribution to their students and the community. The message I sent, before your call, to Mr. Lina *via* his webmail, with a comparable message to Mr. McHale, read:

"I am director & co-founder of the non-partisan, non-profit citizens' organization Center for Judicial Accountability, Inc. (CJA). What a wonderful opportunity you are providing to your students -- and the community -- by the political debate you are holding on Thursday, October 24th between the Erie County D.A. candidates, Acting D.A. Keane and Challenger Gardner. I have primary-source, documentary evidence pertaining the fitness of the candidates, including correspondence to both of them -- and the press -- with questions for them to answer, starting with the D.A. salary.
