A Professional Disciplinary Complaint, dated May 3, 2012, having been filed with the Committee on Professional Standards against FREDERICK J. SCULLIN, JR., for his misconduct as a United States Attorney for the Northern District of New York, and the Committee on Professional Standards *sua sponte* having referred such complaint to the Attorney Grievance Committee for the Fifth Judicial District, and it

APPEARS, that **WILFRED FEINBERG**, as a U.S. District Court Judge was the author of *Perez v. United States* (218 F. Supp. 571 [SDNY-1963]), and was a panel member in *Myers v. United States Postal Service* (527 F.2d 1252 [2nd Cir.-1975]), and knew that in having U.S. Attorney *Frederick J. Scullin, Jr.* him & other federal jurists in their “*personal capacities*” and where there was no 28 *U.S.C.* §2675 “notice of claims” filed they were defrauding the United States, a felony, and triggering a “*subject matter jurisdictional*” lethal infirmity rendering the merit dispositions to be “*null & void*”; and it further

APPEARS that **WILFRED FEINBERG** is a “serial felon” having been previously *unlawfully* represented under similar circumstances by U.S. Attorneys *Rudolph W. Giuliani, Samuel A. Alito, Andrew J. Maloney* and numerous times afterwards; it is

ORDERED that this Court refers this matter to the Departmental Disciplinary Committee, the Public Integrity Section of the U.S. Department of Justice and the Congress of the United States to institute such proceedings as they may seem just & proper in the premises.
