Gentlemen:

1. The body of my letter of February 3, 1989 to the above, to which there was deliberately no response, was as follows:

"In the event that you did not serve on the Attorney General of the State of New York and file with the County Clerk, your <u>Bus. Corp. Law</u> §1207(C)(3), which was due by February 1, 1989, kindly forward to Hon. Sol Wachtler, Chairman of the Administrative Board of the Unified Court System, at Court of Appeals Hall, 20 Eagle Street, Albany, New York 12207, with a copy to the undersigned, a verified statement of <u>all</u> Puccini's assets, of all kind and nature, an item which must be included in such statement.

Also forward to the above a copy of your 'final accounting' which was 'approved' by Referee Donald Diamond on October 26, 1988.

I, as well as others, have not been able to find same, as part of the aforementioned Order."

- 2a. Where there is a court-receiver appointed, as is Mr. Feltman, in <u>all</u> American jurisdictions, there <u>must</u> be a filed accounting, since the public is entitled to know how the judiciary and their cronies dispose of judicial trust assets.
- b. There is no possible way that Feltman can truly account for Puccini's assets in view of the massive larceny and plundering that occurred.

- c. Consequently, in conspiratorial concert, with Robert Abrams, Esq., David S. Cook, Esq., Referee Donald Diamond, and others, he had Referee Diamond, on October 26, 1988, not exist.
- 3a. Hon. SOL WACHTLER, as Chairman of the Administrative Board for the Unified Court System, as well as the public, are entitled to know how Feltman and his criminal coconspirators, cronies of Presiding Justice FRANCIS T. MURPHY and Administrator XAVIER C. RICCOBONO, handle judicial trust assets.
- b. Hon. SOL WACHTLER, as Chairman of the Administrative Board for the Unified Court System, as well as the public, are entitled to know that "the rule of mandatory law" is being disobeyed by Feltman and his co-conspirators in their criminal adventures.
- 4. Feltman, as well as his co-conspirators -- "the criminals with law degrees" -- after being afforded "due process" by your committee, must suffer the ultimate disciplinary penalty.
- 5. Since the request to Mr. Feltman was extensively distributed to the media, this complaint is similarly being extensively distributed.

6. To expedite a response by Mr. Feltman, a copy of this complaint is being sent directly to him.
