Re: Grievance Comm. v. G. Sassower

Honorable Sir:

1a. Children may close their eyes believing they thereby make themselves invisible, but its imitation can prove to be disasterous when attempted by adults!

b. No one, including Your Honor, should attempt to underestimate the quality or quantity of my evidence of larceny of judicial trust assets, perjury, corruption, blackmail, and criminal extortion, by KREINDLER & RELKIN, P.C. ["K&R"], FELTMAN, KARESH, MAJOR & FARBMAN, Esqs. ["FKM&F"], and their corrupt stable of "judicial lackeys"!

c. No one, including Your Honor, should attempt to underestimate my determination in this matter!

2a. Anyone, in my opinion, who appreciates the available evidence and my determination in this matter, and associates themselves with K&R and/or FKM&F, is an "idiot"!

b. This is precisely my opinion of the petitioner's counsel, Robert H. Straus, Esq.

c. K&R and FKM&F, are nothing better than "thieves"! They cannot account for the judicial trust assets of PUCCINI CLOTHES, LTD., without again confessing to their criminality, in a thousand light years!

3a. Enclosed please find (a) "Do You Want To Win A Pulitzer Prize ..."; (b) the first chapter of "An Anatomy of Judicial Corruption"; (c) "Steal, Perjure, Plunder and Extort with Impunity"; (d) a copy of my letter to Hon. Warren E. Burger; and (e) my petition to "Impeach Administrative Judge Xavier C. Riccobono".

c. Within the next few days, I will have completed my mailing to every Bar Association in the State of New York; every newspaper in the State of New York; every T.V. station in the State of New York; every radio station in the State of New York; every Senator of the State of New York; every assemblyman in the State of New York; many of the nations law and journalist schools; all federal and all state officials who may have jurisdiction in this matter; and various other groups and associations.

4a. Mr. Straus desires to disbar me so that I may have more time to publish, and to make TV and radio appearances!

b. I have become a newsworthy commodity!

c. Imprisoned three (3) times in one (1) year; five (5) times in ten (10) years. Even John Dillinger could not accomplish that feat!

d. More than one hundred fifty (15) years ago, James Buchanan, the fifteenth President of the United States, promised that no attorney in the United States would again be incarcerated for non-summary criminal contempt, without a trial (Nye v. United States, 313 U.S. 33, 46), and I have five (5) times endured such unconstitutional incarcerations!

5a. Mr. Straus claims that I have rained havoc on the judicial system, and must be stopped!

b. Mr. Straus does me an injustice!

c. A judicial system wherein one can be convicted, sentenced, and incarcerated, without benefit of a trial; where one can purchase his freedom for money; where orders are issued to "break into" my premises and "seize all word processing and software", and nothing is said or done by the judiciary, cannot justify its existence, and should be totally destroyed!

6a. Unless, all the hundreds of thousands of dollars that has been given by HYMAN RAFFE since July 1, 1985 is returned to him, with interest, by Friday noon, January 23, 1987, or he is incarcerated by such date and hour, as I and Mr. Polur were incarcerated, under those "sham" convictions by Mr. Justice ALVIN F. KLEIN, all "hell" will break loose.

b. To convict and sentence, particularly without a trial, ministerially mandated by the Constitution of the United States, in order to criminally extort, is the ultimate anathema!

c. I desire to make it eminently clear that I would rather see my mother and children incarcerated, then to have them make payments to the like of K&R and FKM&F!

d. My word processor and photostate machine are ready to go forward unless I hear by the above date and hour that such monies have been returned or that Mr. Raffe has been incarcerated!

e. There is no justice, unless there is equal justice! There is no justice, where justice can be bought and sold!
