Dear Sirs:

- 1a. Enclosed please find my letter to the Presiding Justices of the three (3) other judicial departments, dated Feb. 16, 1987, which has as its immediate purpose the removal of Presiding Justice Francis T. Murphy -- "In the name of God, go"!
- b. Jurists in  $\underline{my}$  country do not conduct themselves in the criminally depraved manner as set forth, in part, on page 4, of such letter.
- c. As long as Your Honors bondage yourselves to the criminals/imbeciles in the Feltman and Kreindler firms, I am invulnerable.

It must be remembered, I have the evidence, I have copies of the documents, and I have the confessions!

- d. In Your Honors' upside-down world, Murphy's "criminal, fat cat friends" cannot account for judicial trust assets, because of their unabashed larceny, therefore I, not they, go to jail, without even the benefit of a trial.
- e. Simultaneously, Your Honor's, in the most sanctimonious language disbar attorneys, who because of pressing personal problems, temporarily "dip into" escrow funds, with the blood-thirsty Murphy ["Hypocrite Incarnate"], crying for more of such disbarments (see "Did You Read The News' Editorial of Jan. 28, 1987?"].
- f. The decent members of our society, can be identified, during this bicentennial year, as those who vomit at the prevailing situation.

- 2a. No, I will not remain inert nor silent about the matter!
- b. The judicial proceedings in Nuremburg, after the close of World War II, resolved the issue concerning "the crime of obedience" and its twin, "the crime of silence".
- c. I did not go, in almost one year, from the beaches of Normandy to Germany, see the dead and the wounded, in order to say Heil Murphy!, Heil Riccobono!, Heil Gammerman!, or Heil Diamond! or Heil Anybody -- I will breathe according to my own honest fashion!
- 3a. What Your Honors intended to accomplish by Barr v. Sassower (121 A.D.2d 324, 503 N.Y.S.2d 392), will always be an unfathomable enigma to me, since most of you know me very well!
- b. The Court's decision was my victory, my triumph, my glory!
  - c. To paraphrase Bartelemeo Vanzetti:

"If it had not been for this decision, I might have lived out my life talking at street corners to scorning men. I might have died, unmarked, unknown, a failure. Now I am not a failure. This is my career and my triumph. Never in my full life could I have hoped to do such work for justice, for an honest judiciary, for honest men, as now I, by accident. My words -- my life -- my pains -- nothing! The taking of my liberty -- liberty of a good and poor lawyer -- all! That last moment belongs to me -- that agony is my triumph."

- d. After such decision, everyone was convinced of the extant corruption in Your Honors' Court.
- 4a. Who else, but these imbeciles would appeal the Order of Judge David N. Edelstein, which simply held, inter alia, that I was entitled to a trial, when the charge is criminal?
- b. I openly offered this Court to accept six (6) months incarceration, not thirty (30) days, if found guilty of a single, not sixty-three (63) counts of criminal contempt, after a fundamentally fair trial, held according to law.

The offer was not accepted by Your Honors or the "criminals with law degrees"!

c. It was I, the accused, who moved for such trial, immediately after the Order of Judge David N. Edelstein -- it was my accusors, and their "bald turkey", Mr. Justice Gammerman, who stayed same!

- Everyone, but everyone, comes to the same irresistible conclusion!
- Riccobono and Murphy have transmogrified the courthouses into "whorehouses"!
  - Who is paying for such appeal? 5a.
- Without a trial, Mr. Justice Alvin F. Klein, another one of their "judicial whores", convicted and sentenced Hyman Raffe ["Raffe"], Sam Polur ["Polur"], and myself to be incarcerated for thirty (30) days.
- Raffe, who has paid the Murphy-Riccobono "bag-men", hundreds of thousands of dollars, in addition to agreeing to pay the cost of this appeal, is not incarcerated.
- When Polur leaves the scene, after serving his term, the disciplinary proceedings against him, based on such sham conviction, are dropped.
- Since I refuse to succumb, the disciplinary proceedings against me, based on such sham convictions, are continued.
  - f. Great story for the media!
- Of course, the Circuit Court of Appeals, will reverse the Order of Judge David N. Edelstein. Everyone recognizes that the Feltman firm hardly ever goes into court, or takes an appeal, without a "fix" being arranged!
- Sometimes, they slip up, as they obviously did with U.S. Magistrate Nina Gershon and Judge David Edelstein.
- c. The "criminals with law degrees", and their corrupt judicial and political patrons, were able to "fix" the Circuit Court of Appeals before, and probably will attempt a repeat performance.
- So, I will spend a few more days in jail with people, whose only crime, in many cases, is that they made a single mistake on a single occasion!
- While I never leave my apartment without locking the door, I never locked my cell, unless ordered!

The most dangerous aspect about being incarcerated in the Bronx House of Detention, is the four (4) block walk to the subway station, once you are released!

Ironic?

- 7a. Of one thing Your Honors can be assured, I will obtain full propaganda value both before and after the decision by the Circuit Court of Appeals.
- b. I trained, for a time, with the 101st and 82nd Airborne, and to the demand for surrender, it was, and always will, be "nuts" -- as it was in December of 1944!
- c. These "bastards" will account, for "judicial trust assets" even if I am incarcerated three (3) times each year, without a trial, for the next one hundred (100) years!
- 8a. The reasonable man conforms to society, the unreasonable man wants society to conform to him. The long hard march out of the cave has been the end product of the unreasonable man. I am not only unreasonable, I am incorrigible!

b. The judiciary will clear their own house, or I, with the help of the media, will do it for them!
