The state's top judges have launched a formal inquiry into allegations that a powerful Bronx Judge used his post to steer business to an insurance firm headed by a friend and a relative.

The highly unusual investigation of Justice Louis Fusco Jr. could result in his being removed as administrator of the Bronx Supreme Court's civil division.

State Chief Administrative Judge Albert Rosenblatt confirmed that James D. Hopkins, a retired state Appellate Division judge, has been given subpena power to conduct the inqui-

## Result of News stories

The probe was sparked by Daily News stories that quoted lawyers saying Fusco recommended that they use the insurance agency. The News has also confirmed that the firm, American Structures Ltd., was involved the settlements of at least six medical malpractice cases over which Fusco presided.

The firm could have earned more than \$100,000 in commissions from the cases.

Carole Tindall, a long-time friend of Fusco, is president of American Structures. State insurance records show that Michael Borrelli, a Yonkers insurance broker identified by the state attorney general's office as Fusco's nephew, is vice president.

In a July 25 letter, Rosenblatt told Hopkins to explore allegations "that while functioning in his judicial capacity, Justice Fusco allegedly improperly advanced private business interests of others in connection with case settlements."

Hopkins was asked to submit findings by Aug. 15. He declined comment yesterday.

Rosenblatt said Hopkins Is authorized "to take any steps he feels are appropriate to determine if there was any impropriety" involving Fusco and American Structures.

American Structures specializes in purchasing life insurance annuities that are typically used to guarantee settlements paid over a period of years to victims of medical malprac-

## Repeated recommendations

Two attorneys have told The News that Fusco, who holds sway over all Bronx Supreme Court civil actions, repeatedly recommended the company to lawyers handling malpractice

The attorneys and a third source, who all asked not to be identified for fear of retribution, charged that Tindall at times participated in settlement conferences held in the judge's chamber.

Calling the recommendations "improper," one attorney said, "I don't think that in his position as a judge he should be recommending one company versus another."
