Re: "The Mother of All Judicial Frauds."

Dear Ms. Bird,

While I was incarcerated in Rochester, Minnesota--
- "The American Gulag", you featured me in your July 13, 1989
publication.

A prime reason for the most unusual, if not
unlawful, pre-trial, without bail, incarceration, for a mere
offense, was to facilitate the July 24, 1989 "approval" of the
"final accounting" by a court-appointed receiver, a copy of
which is enclosed.

However, anything asserted in the Order of July
24, 1989 notwithstanding, there is no accounting for this
judicial trust and what was "approved" was an "accounting" which
did not exist.

In every American jurisdiction, a court-appointed
receiver, an arm of the court, must account for his stewardship.

However, in the case of Puccini Clothes, Ltd.--
"the judicial fortune cookie" -- all of its judicial trust assets
were made the subject of larceny, leaving nothing for its
legitimate creditors.

Since Clapp & Eisenberg, P.C. represent the court-
appointed receiver; and Sills, Cumis, Zuckerman, Radin, Tishman,
Epstein & Gross, P.C., represent the court-appointed accountants
for the Puccini, you should have no difficulty in confirming the
non-existence of this "approved" of a 'phantom' "final
accounting".

After you have satisfied yourself that the
aforementioned accounting does not exist, I will mail you further
particulars, with documentation, of egregious criminal activity
by the federal bench and bar in the Third Circuit.
