Dear Mr. Cahill,

1.. On October 20, 2004, when my complaint had been served on the above and your office, Mr. Justice E. Michael Kavanagh, had not rendered a single decision with respect to my pending actions in Westchester County, and none was expected until, at least October 29, 2004, a date set by Mr. Justice Kavanagh for a "conference" with all the parties.

My complaint against the above was based, almost exclusively, on their activities, which conclusively proved, that Mr. Justice Kavanagh was a "corrupt" jurist, who had been "fixed"!

Indeed, the above attorneys were effectively openly flaunting that both Mr. Justice Kavanagh and Administrator Francis A. Nicolai of Westchester County had been "fixed".

- Then, unexpectedly, on October 23, 2004, three (3) days after I served my instant complaint, I received Orders from Mr. Justice Kavanagh, dated October 18, 2004, in an envelope post-marked October 20, 2004, which Orders were inundated with hard evidence of Kavanagh's corruption, only one of which, at this time and place, is here set forth.
- In the civil action entitled Geo. Sassower, individually & as Trustee v. Feltman, Karesh, Major & Farbman, et el. (Supreme Westchester Docket No. 92-20421), Mr. Justice Kavanagh wrote "Mr. Sassower is hereby directed to appear at the Westchester County Courthouse on October 29, 2004 conference for the purposes of determining whether Mr. Sassower shall be held in contempt for his continued violations of Court orders and, if so, to determine what punishment and sanctions should be imposed. Mr. Sassower is hereby put on notice that this Court intends to address his repeated failure to comply with Court orders issued in these proceedings and that he has the right to obtain counsel and have counsel present at that time to represent his interests."
- 4. Every attorney knows, or can easily verify, that in every court, in every jurisdiction, including New York, particularly since *Bloom v. Illinois* (391 U.S. 194 [1968]), which brought non-summary criminal contempt under the protective umbrella of the *Constitution of the United States*, is prosecuted not in a civil proceeding, but by an independent special proceeding, information or indictment by a government attorney or person appointed by the court for such purpose, and in a public courtroom, not in conference!

I challenge each and every attorney accused herein, to swear under oath, or affirm under penalty of perjury, that the Kavanagh "direction" or procedures have legal validity?

In short: despite the physical adornment of his judicial robe and title, he is acting without "jurisdiction", as an "usurper", "pretender", "imposter", impersonator", "charlatan", "quake", is "legally disrobed" and acting "coram non judice".

There is no jurist who is so stupid, that he/she would issue such directive.

Kavanagh's usurpation of lawful authority is deliberate and intentional, as part of an egregious criminal racketeering adventure, involving "millions of dollars" in "bribes, and he simply is following the example of other corrupt jurists.
