The plaintiff-petitioner, GEORGE SASSOWER, having commenced three separate proceedings as follows:

ACTION NO. 1:

An Article 78 proceeding seeking an order to restrain the respondent, Sheriff of Suffolk County, his servants, agents and/or employees from entering any county outside Suffolk County for the purpose of arresting petitioner Sassower, prohibiting them from removing Sassower from the county of his arrest or detention, and/or restraining them from preventing Sassower from seeking a Writ of Habeas Corpus in the county of his arrest and detention and the District of Federal Court of such arrest and detention;

ACTION NO. 2:

A Habeas Corpus proceeding to review petitioner-relator Sasso s incarceration by the Sheriff of Suffolk County pursuant to a warrant of mitment and contempt citation, both issued by the Surrogates Court of Suffc.. County on March 8, 1978;

ACTION NO. 3:

An action alleging, inter alia, tort claims in which plaintiff

Sassower seeks ten million dollars in compensatory damages and ten million

dollars in punitive damages; and

The plaintiff-petitioner George Sassower having interposed the following applications:

ACTION NO. 2 (Habeas Corpus):

For an order of "summary judgment" sustaining the writ of habeas corpus;

ACTION NO. 3 (Tort Action):

For an order of "Judgment on the Pleadings/Summary Judgment" in favor of plaintiff against the defendant, New York News, Inc., on his second cause of action, or in the alternative to sever such cause against this defendant and for a protective order; and

The defendant-respondents, having interposed the following applications:

ACTION NO. 1 (Article 78 Proceeding):

For an order pursuant to CPLR \$7804(f) by the Sheriff to dismiss, raising objections in point of law;

ACTION NO. 2 (Habeas Corpus):

- I. By the Public Administrator of Suffolk County for an order seeking:
 - a) Permission to intervene in Action Nos. 1 and 2;
 - h) Referral of Action Nos. 1 and 2 to the Appellate Division, Second Judicial Department for hearing and determination; and
 - c) In the alternative, dismissal of Action Nos. 1 and 2; and
- granting a summary hearing on the habeas corpus application;

- a) Pursuant to CPLR \$602(a) consolidating these three actions; and
 - b) Pursuant to CPLR \$3212 granting summary judgment.

Lazer dated November 14, 1978 and entered November 20, 1978 transferring venue of Action No. 3 from Westchester to Suffolk County; defendants' Signorelli and Seidell notices of motion to dismiss dated November 17, 1978 and January 15, 1979; plaintiff's notice of motion dated January 18, 1979 seeking summary judgment against defendant New York News, Inc., etc.; affidavit in opposition of Harry J. AND Plaintiff-petitioner George Sassower having appeared, pro se; defendants and/or respondents Sheriff Finnerty. Deputy Sheriffs Croce and Grymalski [sic], Public Administrator Mastroianni, having duly appeared by David J. Gilmartin, Suffolk County Attorney, by Erick F. Larsen, Assistant County Attorney; defendants Judges Signorelli and Seidell having duly appeared by the New York Attorney General, Robert Abrams; defendant New York News, Inc., having duly appeared by its attorneys Townley & Updike, Harry H. Wise, III. of counsel; and Public Administrator of Suffolk County Mastroianni, in his capacity as Temporary Administrator of the Estate of Eugene Paul Kelly, having duly appeared by his attorney Vincent G. Berger, Jr.;

AND a summary hearing having been conducted by this Court on March 27, 1979 in connection with the writ of habeas corpus (Action No. 2); and the matters having been otherwise submitted by all parties; and after due deliberation having been had; and for the reasons more fully set forth in the memoranda of this Court dated March 20, 1980 and April 24, 1980;

IT IS FURTHER ORDERED that in light of the dismissal of Action No. 1, the Public Administrator's application to intervene in Action No. 1 is denied as academic; and :

IT IS FURTHER ORDERED that the Public Administrator's application to intervene in Action No. 2 is denied as academic; and

IT IS FURTHER ORDERED, ADJUDGED AND DECRE:D that defendant Judges Signorelli and Seidells' application to dismiss Action No. 3 as against them pursuant to CPLR §3211(a)(7) is granted; and

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that plaintiff Sassower's application for summary judgment against defendant New York News, Inc., in Action No. 3 is denied; and

IT IS FURTHER ORDERED that plaintiff Sassower's application for a protective order with respect to defendant New York News, Inc.'s notice to take the oral deposition of the plaintiff (Dated January 12, 1979) (Action No. 3) is denied; and

IT IS FURTHER ORDERED that plaintiff Sassower's application for severence of his claims against defendant New York News, Inc. (Action No. 3) is denied; and

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that petitioner-relator Sassower's writ of habeas corpus (Action No. 2) is dismissed; and

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that petitioner Sassower's application for "summary judgment" on the writ of habeas corpus (Action No. 2) is denied; and

IT IS FURTHER ORDERED that the Order of Recognizance dated June 10, 1978 issued pursuant to CPLR \$530.60 in connection with the writ of habeas corpus (Action No. 2) is revoked; and

IT IS FURTHER ORDERED that petitioner Sassower will surrender himself to the custody of the Sheriff of Suffolk County within forty-eight (48) hours after service upon him of this order with notice of entry; and

IT IS FURTHER ORDERED that in the event plaintiff fails to surrender himself as aforestated, respondent Sheriff is granted leave to apply to this Court for an ex parte Order of Commitment; and

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Suffolk defendants' application for summary judgment in Action No. 3 is denied without prejudice to renewal before this Court upon a more detailed substantiation of the contention that the plaintiff is barred by principles of claim and/or issue preclusion from relitigating issues previously determined against him in prior related federal proceedings; and

IT IS FURTHER ORDERED that Suffolk defendants' application for an immediate hearing upon petitioner Sassower's writ of hebeas corpus is granted only to the extent of the hearing already conducted by this Court on March 27, 1979, and is otherwise denied; and
