

GEORGE SASSOWER, Esq., first being duly sworn, deposes and says:

I am the plaintiff in the within matter and make this affidavit in support of a motion directing that an inquest be taken before this Court by the plaintiff and judgment be entered thereon for failure of defendants to timely answer the complaint, alternatively, for a formal decree pro confesso together with such other relief as to this Court may seem just and proper.

All defendants have been served herein except for the defendant, VINCENT G. BERGER, JR., by the United States Marshal.

On November 25, 1978, a"Notice of Default" (Exhibit "A") was mailed to all defendants except for VINCENT G.

BERGER, JR., with a copy and proof of service being mailed to the Clerk of this Court and docketed on November 29, 1978.

That none of the defendants responded except for the defendants ERNEST L. SIGNORELLI and HARRY E. SEIDELL, who served an answer by LOUIS J. LEFKOWITZ, Attorney General of the State of New York, which answer was rejected the same day it was received (Exhibit "B"). The original Notice of Rejection, with proof of service, was docketed in this Court on December 5, 1978.

I see no purpose of accepting an answer which clearly violates Rule 11 of the Federal Rules of Civil Procedure as "sham and false".

Initially, plaintiff proceeded by Order to Show Cause but was advised by the Court that he should and may proceed by Notice of Motion.

WHEREFORE, it is respectfully prayed that the relief sought herein be granted in all respects.
