TO THE HONORABLE JUSTICES OF THE SUPREME COURT OF
THE STATE OF NEW YORK: COUNTY OF WESTCHESTER

The petition of GEORGE SASSOWER, respectfully
shows and alleges:

1. Petitioner is a resident of the County of Westchester, State of New York and a citizen of The State of New York and The United States of America.
2. Respondent, JOHN P. FINNERTY, is the Sheriff of Suffolk County.
3. On or about March 8, 1978 there was issued to the Respondent a Warrant of Arrest against the Petitioner based upon an Order of Criminal Contempt.
4. That such Warrant of Arrest and Order of Criminal Contempt are clearly and patently unconstitutional and known to the Respondent as illegal and unconstitutional.

5. That almost exclusively the Petitioner is in the counties of Westchester, Bronx, or New York, all of which are within the Federal jurisdiction of the Southern District of New York.

6. That in violation of the Constitutions of the United States and State of New York, the laws, statutes, usages and customs of the United States and State of New York the Respondent intends to arrest and detain the Petitioner in counties outside of Suffolk County and within the Southern District of New York, abduct Petitioner and remove him to Suffolk County without permitting Petitioner to obtain a Writ of Habeas Corpus in the County of his arrest or in the Southern District of New York, as was previously done under similar adjudicated invalid documents.

WHEREFORE, Petitioner prays that an Order be entered restraining the Respondent, his servants, agents, and/or employees from entering any county outside of Suffolk County for the purpose of arresting Petitioner, prohibiting them from removing Petitioner from the County of his arrest or detention, and/or restraining them from preventing Petitioner from seeking a Writ of Habeas Corpus in the county of his arrest and detention, and the District of the Federal Court of such arrest and detention, together with any other and
