I verify the correctness of the factual statements by Doris L. Sassower, Esq. as contained in her aforesaid affidavit insofar as they relate to me, her statements concerning Erick F. Larsen, Esq. at the Appellate Division, the testimony of Ernest L. Signorelli, the testimony of Deputy Sheriff Anthony Grzymalski, and all incidents involving me.

With respect to the <u>sua sponte</u> published statement of Ernest L.
