Morris identified himself as follows: Sassower, I am Deputy Sheriff Morris from the Suffolk County Sheriff's Dept."; at which point D/S Morris displayed his I.D. Card and Shield stating, "I have a Suffolk County Surrogate's Court Warrant of Commitment for you and you are under arrest". At the same time, D/S Grzymalski identified himself by stating, "I am Deputy Sheriff Grzymalski, Suffolk County" and displaying his I.D. Card and Shield. At this point, subject was escorted to Sheriff's Unit 115 which was parked on street in front of subject's house. While walking toward Unit 115 subject began pushing and shoving D/S's Morris and Grzymalski, screaming at the same time that he wanted a police officer. At this point, subject was handcuffed (in front) by D/S Morris. Subject was then placed in rear seat of Unit 115. D/S Morris then provided subject with copy of Warrant while showing him original Warrant. Subject was then advised of his Constitutional rights by D/S D/S Grzymalski proceeded to drive away while D/S Morris was seated in front seat on passenger side and subject in back seat. While driving, subject began opening the rear seat window, yelling out, "Police, Police, help". While driving on North Street in the city of New Rochelle, subject again began to open window, yelling out, "Police, Police"; then grabbing the door handle. At this point, D/S Grzymalski stopped the vehicle for the purpose of handcuffing subject behind his back so he would not open the door while driving. D/S Morris opened the rear door and subject began pushing and kicking at both D/S Morris and D/S Grzymalski, striking D/S Grzymalski in the stomach and groin several times. At this point, D/S Morris sat in the back seat with subject while D/S Grzymalski proceeded around the other side of vehicle to begin driving. Subject then opened the rear door of vehicle and 'began to flee, at which time D/S Morris attempted to subdue subject. D/S Grzymalski returned to D/S Morris' aid when subject began pushing and kicking again, striking D/S Grzymalski in the lower abdominal area of his body several times. Subject was subdued and D/S Grzymalski proceeded to drive vehicle while D/S Morris was seated in rear seat with Subject sat quietly for a few minutes but then began reaching for the door handle several times. Once vehicle entered onto N. Y. S. Thruway subject became quiet again. thereafter, subject stated to D/S Morris, "Read me my rights again and loosen these handcuffs." D/S Morris then loosened subject's handcuffs and locked them so they wouldn't tighten up if he began moving and resisting again. D/S Morris then read subject his Constitutional rights again. Subject then sat quietly. When vehicle stopped at the Throggs Neck Bridge to pay toll, subject began yelling to Toll Officer, "help me, get the police"; at which time D/S Grzymalski identified himself to the Toll Officer by displaying his I.D. Card and Shield. While on the L.I.E. subject stated he wanted to make a phone call at which time he was advised by D/S Morris he could make a call as soon as we arrived at the jail.
