In addition thereto, the records of this federal Court reveals that the monetary fines and penalties imposed by U.S. District Court Judge EUGENE H. NICKERSON, by Order of June 7, 1985, "payable to the [federal] court" was never received by it.

Consequently, <u>demand</u> is made the information requested herein be served upon the undersigned and with the Clerk of the United States District Court for the Eastern District of New York, 225 Cadman Plaza East, Brooklyn, New York, 11201, on or before November 25, 1988.

- 1. A copy of the "final accounting" which was approved for settlement by Referee DONALD DIAMOND, as aforementioned.
- 2. A copy of the consent of the Attorney General, the statutory fiduciary, or his representative to such "final accounting", if it exists, and/or copies of any objection to same.
- 3. A verified statement of the "assets" of Puccini Clothes, Ltd., which by legislative mandate of law <u>must</u> be served upon the Attorney General and filed with the County Clerk by February 1 of each and every year (<u>Bus. Corp. Law</u> §1207), for which the records of the County Clerk reveals no such filings due February 1, 1987 and February 1, 1988.
- 4. A copy of the record showing the appointment of Feltman, Karesh, & Major, Esqs., and/or Feltman, Karesh, Major & Farbman, Esqs., and/or Rashba & Pokart pursuant to 22 NYCRR \$660.24, for Puccini Clothes, Ltd., if it exists.
- 5. A copy of all <u>Judiciary Law</u> §35-a filings [22 <u>NYCRR</u> §§26.4, 26.5, §36.4], if any, for awards made to Feltman, Karesh, & Major, Esqs., and/or Feltman, Karesh, Major & Farbman, Esqs., and/or Rashba & Pokart from the judicial trust assets of Puccini Clothes, Ltd.

6. A statement of all monies and other consideration given by Mr. Hyman Raffe to Kreindler & Relkin, P.C.; Feltman, Karesh, & Major, Esqs.; Feltman, Karesh, Major & Farbman, Esqs.; and/or their clients; including general releases or agreements to give general releases to, inter alia, the judges of the United States District Court, Southern and Eastern District of New York, and judges of the New York Supreme Court.
