PETITION FOR A WRIT OF CERTIORARI

STAY APPLICATION

1a. This is an stay application by petitioner, a native-born American citizen and battle starred veteran of World War II, prohibiting defendants Chief Judge CHARLES L. BRIEANT ["Brieant"] of the United States District Court for the Southern District of New York and U.S. District Judge NICHOLAS H. POLITAN ["Politan"] of New Jersey from interfering with petitioner's right of free ingress to the public portions of the Federal Building in White Plains, New York and access to access to public papers and files housed therein.

b(1) A copy of this stay application is being served upon Chief Judge Brieant and Judge Politan, as well as the Solicitor General, since both Chief Judge Brieant and Judge Politan are actively engaged in criminal racketeering activities, which includes the diversion of monies due the government to private pockets.

(2) By reason of such criminal diversion of monies from the sovereign to private pockets, affirmant questions whether the Solicitor General will, or can, represent such federal defendants (cf. U.S. v Providence Journal, 485 U.S. 693 [1988]).

2a. In or about August of 1989, petitioner was informed that Chief Judge Brieant had given oral instructions to the guards and other personnel in said Federal Building that affirmant was not to be given ingress to said Federal Building in White Plains except by his permission and/or the permission of Judge Politan of New Jersey.

b. Such administrative blockade of the Federal Building was thereafter witnessed by a reporter for UNITED PRESS INTERNATIONAL and confirmed by Chief Judge Brieant to Congresswoman NITA LOWEY.

3a. Such blockade was imposed against affirmant by the usual "no due process" procedures of Chief Judge Brieant, as more fully appears in affirmant's petition for a writ of certiorari to this Court dated October 12, 1990 (Docket No.).

b. Chief Judge Brieant and Judge Politan attempt to immunize their acts of misconduct by also decreeing, also without any due process procedures whatsoever, that access to their respective courts, needs judicial consent, which consent is invariably denied.

c. Thus, at bar, petitioner attempted to file a verified complaint which attempted to invalidate the "no due process" edicts of Chief Judge Brieant, including the physical exclusion edict, and permission was denied.

4a. At the present time, as set forth in petitioner's verified complaint, there is litigation taking place in the White Plains Federal Building wherein petitioner's daughter is a party.

b. Although a major part of the allegations in such litigation involves petitioner, since he resides with his daughter, he is excluded from the aforementioned government building and courtrooms therein.

5a. Furthermore, such Federal Building house many papers which are essential to petitioner in order that he may properly vindicate his legal rights.

b. However, by reason of such exclusion edict, these needed papers and documents are unavailable to him.

6. Application for a stay was made to the Circuit Court on September 24, 1990 (Exhibit "A"), but three (3) weeks later, that Court stated it would not entertain such application (Exhibit "B").

7. The aforesaid is stated to be true under penalty of perjury.

WHEREFORE, it is respectfully prayed that the aforementioned relief be granted in all respects.
