
This affirmation, made under the penalty of perjury, is made in support of a stay application, affirmative and negative: (1) to compel KREINDLER & RELKIN, P.C. ["K&R"] to pay the fees due the U.S. District Court for the District of Ohio as a result of affirmant's filings in that Court in partial satisfaction of affirmant's contractually based money judgment of more than \$50,000; (2) to compel appellees, U.S. Attorney D. MICHAEL CRITES ["Crites"] and Attorney General WILLIAM P. BARR ["Barr"] to immediately take such action as may be necessary to recover from K&R and its clients all monies, including monies paid on behalf of affirmant, payable "to the federal court" which were diverted to their pockets; and (3) restrain the appellees from defending federal judges and officials, sued in their personal capacities, who have not been "scope certified" (28 U.S.C. §2679(d)), and being sued for activities contrary to legitimate federal interests.

At no time, at no place, has anyone, including appellees, have even attempted to justify, legally or ethically, the actions or lack of same by those involved in the aforementioned activities.

In view of the relief requested in this application, all irresistibly compelling, where notice is being afforded to everyone concerned, anything more stated herein would be supererogatory.

WHEREFORE, it is respectfully prayed that this application be granted in all respects.


