TO: THE HONORABLE PRESIDING JUSTICE AND ALL JUSTICES OF THE APPELLATE DIVISION OF THE SUPREME COURT OF THE STATE OF NEW YORK, SECOND JUDICIAL DEPARTMENT

The Petition of the Grievance Committee for the Second and Eleventh Judicial Districts respectfully alleges that:

FIRST: By order of this Court, dated and filed June 3, 1985, the Grievance Committee for the Second and Eleventh Judicial Districts (hereinafter "Committee") was authorized to institute and prosecute a disciplinary proceeding in this Court against George Sassower (hereinafter "respondent"), based on the acts of professional misconduct as set forth in the report of the Grievance Committee for the Second and Eleventh Judicial Districts, dated May 13, 1985. Further, said order of June 3, 1985 appointed Robert H. Straus, Esq., as attorney for the petitioner in this proceeding.

SECOND: Said order of June 3, 1985 was duly made and filed by this Court pursuant to Section 90 of the Judiciary Law and Section 691.4 of the Rules Governing the Conduct of Attorneys of this Court.

THIRD: By further order of this Court, dated and filed October 11, 1985, petitioner was authorized to include additional charges, based upon respondent's conviction of serious crimes, in this Petition to discipline respondent for his acts of professional misconduct.

FOURTH: The respondent was admitted to practice as an attorney and counselor-at-law in the Courts of the State of New York, by the Appellate Division of the Supreme Court, Second Judicial Department, on March 30, 1949.

FIFTH: Upon information and belief, respondent, at all times hereinafter mentioned, maintained an office for the practice of law at 2125 Mill Avenue, Brooklyn, New York 11234.

SIXTH: Upon information and belief, respondent has been guilty of professional misconduct as defined by Section 691.2 of the Rules Governing the Conduct of Attorneys in that:

## CHARGE ONE

Respondent has been guilty of professional misconduct prejudicial to the administration of justice and which adversely reflects on his fitness to practice law, as follows:

1. By order of Honorable Ira Gammerman, Justice of the

Supreme Court, New York County, dated January 23, 1985, respondent was permanently enjoined and restrained from filing or serving any further lawsuits relating to Puccini Clothes, Ltd. ("Puccini"), and from continuing to prosecute designated pending lawsuits against specified parties, without leave of court.

- 2. Respondent wilfully and deliberately violated said order.
- 3. By order of Honorable Alvin F. Klein, Justice of the Supreme Court, New York County, dated June 26, 1985 (a copy is annexed as EXHIBIT A), respondent was convicted of criminal contempt of court for having wilfully and deliberately violated the order of Justice Gammerman and was sentenced to a term of imprisonment of thirty days and to fines totalling \$1,250.00.
- 4. On September 17, 1985 the Appellate Division, First Judicial Department affirmed respondent's criminal contempt conviction.
- 5. By reason of the foregoing, respondent has been convicted of a serious crime as defined by Section 691.7(b) of the Rules of the Appellate Division, Second Judicial Department and has violated Disciplinary Rules 1-102(A)(5) and 1-102(A)(6) of the Code of Professional Responsibility.

#### CHARGE TWO

Respondent has been guilty of professional misconduct prejudicial to the administration of justice which adversely reflects upon his fitness to practice law, as follows:

- 1. By order of Honorable Ira Gammerman, Justice of the Supreme Court, New York County, dated January 23, 1985, respondent was permanently enjoined and restrained from filing or serving any further lawsuits relating to Puccini and from continuing to prosecute designated pending lawsuits, against specified parties without leave of court.

  2. Respondent wilfully and knowingly violated said
- 2. Respondent wilfully and knowingly violated said order.
- 3. By order of Honorable David B. Saxe, Justice of the Supreme Court, New York County, dated June 26, 1985 (a copy is annexed as EXHIBIT B), respondent was convicted of criminal contempt of court for having wilfully and knowingly disobeyed the order of Justice Gammerman and was sentenced to a term of imprisonment of ten days and to a fine of \$250.00.
- 4. On September 17, 1985, the Appellate Division,
  First Judicial Department affirmed respondent's criminal contempt
  conviction.
- 5. By reason of the foregoing, respondent has been convicted of a serious crime as defined by Section 691.7(b) of the Rules of the Appellate Division, Second Judicial Department and has violated Disciplinary Rules 1-102(A)(5) and 1-102(A)(6) of the Code of Professional Responsibility.

#### CHARGE THREE

Respondent has been guilty of professional misconduct prejudicial to the administration of justice which adversely re-

flects upon his fitness to practice law, as follows:

- 1. By order of Honorable Eugene H. Nickerson, Judge of the United States District Court of the Eastern District of New York, dated May 28, 1985, respondent was ordered to appear at the United States District Courthouse in Brooklyn, New York for deposition on May 30, 1985.
- Respondent wilfully and deliberately violated said order.
- 3. By order of Judge Nickerson, dated June 7, 1985 (a copy is annexed as EXHIBIT C), respondent was convicted of criminal contempt of court for violating Judge Nickerson's order of May 28, 1985.
- 4. On September 13, 1985, the United States Court of Appeals for the Second Circuit affirmed respondent's criminal contempt conviction.
- 5. By reason of the foregoing, respondent has been convicted of a serious crime as defined by Section 691.7(b) of the Rules of the Appellate Division, Second Judicial Department and has violated Disciplinary Rules 1-102(A)(5) and 1-102(A)(6) of the Code of Professional Responsibility.

## CHARGE FOUR

Beginning in or about May 1980, respondent knowingly and deliberately engaged in professional misconduct which abused the judicial process, interfered with, obstructed and was pre-

judicial to the administration of justice and which adversely reflected on his fitness to practice law, as follows:

- 1. Following the judicial dissolution of Puccini and the appointment of a permanent receiver, beginning in or about 1982 respondent wilfully, knowingly and maliciously initiated, instituted, supervised and directed a continuing flow of vexatious, baseless, frivolous and repetitious litigation pertaining to Puccini.
- 2. Schedule I, annexed to and made a part of this Petition, sets forth said litigation.
- 3. Respondent directed said frivolous and vexatious litigation against litigants, judges, referees, attorneys, public officials and other parties who participated in litigation involving the Puccini dissolution or who rendered decisions or rulings adverse or contrary to positions asserted by respondent.
- 4. Respondent engaged in said frivolous and vexatious litigation for the purpose of harassing, threatening, coercing and maliciously injuring those made subject to it.
- 5. By engaging in said conduct respondent violated Disciplinary Rules 1-102(A)(5), 1-102(A)(6), 7-102(A)(1) and 7-102(A)(2) of the Code of Professional Responsibility.

#### CHARGE FIVE

Beginning in or about September 1980, respondent knowingly and deliberately engaged in professional misconduct

which interfered with, obstructed and was prejudicial to the administration of justice and which adversely reflected on his fitness to practice law, as follows:

- 1. By order of Honorable Hilda E. Schwartz, Justice of the Supreme Court, New York County, dated September 11, 1980 (a copy is annexed as EXHIBIT D), respondent was relieved as counsel in certain proceedings pertaining to Puccini Clothes, Ltd. and was directed to turn over his legal files pertaining to the proceedings.
- 2. By orders of Honorable Thomas V. Sinclair, Jr.,
  Justice of the Supreme Court, New York County, dated February 1,
  1982 (copies are annexed as EXHIBITS E and F), respondent was
  disqualified as the attorney for Hyman Raffe (hereinafter
  "Raffe") in specified Puccini proceedings.
- 3. By order of Honorable Edward J. Greenfield, Justice of the Supreme Court, New York County, dated September 8, 1982 (a copy is annexed as EXHIBIT G), respondent was prohibited from representing Puccini unless expressly authorized by Lee Feltman (hereinafter "Feltman"), Puccini's court-appointed receiver.
- 4. By order of Honorable Xavier C. Riccobono, Administrative Judge of the Civil Branch of the Supreme Court, First Judicial District, dated March 26, 1984 (a copy is annexed as EXHIBIT H), the Puccini proceedings, including all discovery related motions and all factual issues in designated proceedings, were referred for assignment to a referee and all future applications were to contain

an endorsement indicating the terms of Judge Riccobono's administrative order.

- 5. Donald Diamond was appointed Special Referee for specified Puccini proceedings, pursuant to Judge Riccobono's administrative order.
- 6. Referee Diamond directed that all applications to reargue and renew must be brought by order to show cause signed by the judge who had made the original determination and that all other motions must be preceded by a pre-motion-conference with the Special Referee.
- 7. By a ruling of Special Referee Diamond, dated September 26, 1984 (a copy is annexed as EXHIBIT I), respondent was held to be in continuing violation of the previous orders disqualifying, enjoining and otherwise restraining him and was ordered barred from attending all proceedings conducted before Special Referee Diamond from which he had previously been removed as attorney.
- 8. By order of Honorable Thomas J. Hughes, Justice of the Supreme Court, New York County, dated December 7, 1984 (a copy of which is annexed as EXHIBIT J), respondent was enjoined and restrained, pending the determination of the motion for a permanent injunction, from instituting any additional proceedings or serving any additional claims or amended complaints pertaining to Puccini, without leave of court.
  - 9. By order of Honorable Ira Gammerman, Justice of

the Supreme Court, New York County, dated January 23, 1985 (a copy is annexed as EXHIBIT K), respondent was permanently enjoined and restrained from prosecuting or initiating any proceedings pertaining to Puccini against specified individuals, without leave of court; was prohibited from making any motion to vacate, reargue, renew or modify this order except by order to show cause, presented to either Judge Gammerman or to the Administrative Judge of the Court; and was prohibited from making any application, motion or submission pertaining to Puccini without annexing a copy of this order and setting forth a statement as to its existence.

- Judge of the United States District Court for the Southern

  District of New York, dated October 11, 1985 (a copy is annexed as EXHIBIT L), respondent was permanently enjoined and restrained from filing or initiating any action in any federal court or tribunal pertaining to Puccini against specified individuals.
- 11. Respondent knowingly and wilfully disobeyed, violated, and defied the aforementioned orders and rulings by instituting, initiating, filing, submitting and participating in, a continuing series of motions, suits, proceedings (which are set forth in Schedule I).
- 12. Respondent knowingly and wilfully disobeyed, violated and defied said orders and rulings by making numerous appearances in which he purported to represent Puccini, Hyman Raffe, or both.

13. By engaging in the aforesaid conduct, respondent violated Disciplinary Rules 1-102(A)(5) and 1-102(A)(6) of the Code of Professional Responsibility.

## CHARGE SIX

Respondent has been guilty of failing to seek the lawful objectives of a client and of prejudicing and damaging a client, as follows:

- 1. In or about 1979 respondent was retained by Hyman Raffe("Raffe") to represent him with respect to the Puccini dissolution proceedings.
- 2. In or about January 1985, respondent was instructed by Raffe to commence no further litigation with respect to Puccini in Raffe's name or on his behalf.
- 3. Respondent deliberately and wilfully disregarded and violated Raffe's instructions by instituting, filing and submitting numerous actions, proceedings and appeals pertaining to Puccini on Raffe's behalf.
- 4. As a direct result of respondent's unauthorized behavior, Raffe was assessed costs, attorneys' fees, fines and penalties and was held to be guilty of civil and criminal contempt of court.
- 5. By engaging in the aforesaid conduct, respondent violated Disciplinary Rules 1-102(A)(5), 1-102(A)(6) and 7-101(A)(1) and 7-101(A)(3) of the Code of Professional Responsibility.

## CHARGE SEVEN

Respondent failed to cooperate with the Committee in its legitimate investigation of a complaint of professional misconduct made against him, as follows:

- 1. By letter dated December 5, 1984, respondent was provided with a copy of the complaint of Donald F. Schneider, Esq., was requested to provide a written answer to the allegations and was informed that an unexcused failure to respond constituted professional misconduct.
- 2. In a letter dated December 14, 1984, respondent acknowledged receipt of the complaint and stated that he had not read it and did not intend to do so.
- 3. Respondent failed to respond to the allegation of misconduct as requested.
- 4. By letter dated January 3, 1985, respondent was again informed that his written response to the complaint was required and was again advised that a failure to respond constituted professional misconduct.
- 5. In letters dated January 14, 1985 and January 22, 1985, respondent again failed to respond to the allegations of the complaint.
- 6. In letters dated January 28, 1985 and January 30, 1985, respondent made the deliberately false representation that a court order prohibited him from responding to the allegations of the complaint.

7. By engaging in the aforesaid conduct, respondent violated Disciplinary Rule 1-102(A)(6) of the Code of Professional Responsibility.

WHEREFORE, petitioner prays that an order directing that the respondent, George Sassower, as an attorney and counselor-at-law be disciplined upon the charges as set forth herein, and for such other action as may be contemplated by Section 90 of the Judiciary Law of the State of New York.
