The Administrative Judge of the Civil Branch of the Supreme Court, First Judicial District, pursuant to the authority conferred upon him does hereby order the following change in case assignment in New York County.

WHEREAS, the following actions and proceedings presently are pending in the Civil Branch, New York County, Supreme Court:

1. In the matter of the Application of Jerome H. Barr and Citibank, N.A., as Executors of the Will of Milton Kaufman, Holders of One-Quarter of All Outstanding Shares of Puccini Clothes, Ltd. 3. Hyman Raffe, Plaintiff against Eugene Dann, Robert Sorrentino and Lee Feltman, as Receiver for Puccini Clothes, Ltd., Defendants (New York County Index No. 10400/83).
4. Lee Feltman, as Receiver for Puccini Clothes, Ltd., Plaintiff, v. Eugene Dann and Robert Sorrentino, Defendants (New York County).
5. Jerome H. Barr and Citibank, N.A., as Executors of the Will of Milton Kaufman, Plaintiffs, against Hyman Raffe, Eugene Dann, Robert Sorrentino and Puccini Clothes, Ltd., Defendants (New York County Index #21208/79) and;

WHEREAS, the attorneys for the court-appointed receiver of Puccini Clothes, Ltd. have made application on notice to counsel for all parties, for appointment of a single justice to be assigned each of these cases for all purposes,


NOW, upon due consideration of the papers submitted in support of and in opposition to the application, and upon review of all the attendant circumstances, it is

ORDERED, that the pending dissolution proceeding entitled In Re Application of JEROME H. BARR AND CITIBANK, N.A., as EXECUTORS OF THE WILL OF MILTON KAUFMAN, Holders of One-Quarter of All Outstanding Shares of PUCCINI CLOTHES, LTD., Entitled to Vote in an Election of Directors, hereby is referred to Trial Term, Part 10 for assignment to a referee to hear and determine all remaining issues except those presently sub judice, before a justice of this Court, and it is further:

ORDERED, that all discovery related motions in the actions enumerated above, hereby shall be referred to the above assigned referee to hear and determine, and it is further:

ORDERED; that all factual issues raised by any motions in these actions and proceedings hereby shall be referred by the Justice presiding in Special Term, Part I to the above assigned referee to hear and report with recommendations, and it is further:

ORDERED, that all future applications with the Court shall contain an endorsement indicating the terms of this Administrative Order.
