## JOINT CERTIFICATE

### Pursuant to Joint Rules II and III of the Permanent Rules of the Senate and the Assembly

Whereas, Joint Rules II and III of the Permanent Rules of the Senate and Assembly provide for the convening of joint conference committees to resolve differences between similar bills or resolutions adopted by each house of the Legislature; and

Whereas, the Governor has submitted certain appropriation and nonappropriation bills pursuant to Article VII of the New York State Constitution as part of the 2013-2014 executive budget; the Senate has passed a resolution addressing such appropriation and nonappropriation bills submitted by the Governor (Senate Resolution R818) and incorporating bills (S.2600-C, S.2603-C, S.2604-C, S.2605-C, S.2606-C, S.2607-C, S.2608-C, S.2609-C,) and the Assembly has passed a resolution addressing such appropriation and nonappropriation bills submitted by the Governor (Assembly Resolution 182) and incorporating bills (A.3006-C, A.3001, A.3002, A.3003-C, A.3004-C, A.3005-C, A.3006-C, A.3007-C, A.3008-C and A.3009-C); and

Whereas, such resolutions addressing such appropriation and nonappropriation bills which has been passed by or may be passed by each house of the Legislature contains substantially similar but not identical provisions;

Now, therefore, Dean G. Skelos as Temporary President of the Senate, and Sheldon Silver, as Speaker of the Assembly, hereby certify to the convening of a Joint Committee on Conference on the above-referenced resolutions pursuant to Permanent Joint Rules II and III in accordance with the following:

2. Such Committee on Conference shall be convened as soon as reasonably practicable and shall be dissolved not later than the earlier of the filing of a report pursuant to Joint Rules II and III, or March 18, 2013 unless extended by written notice signed by the Temporary President of the Senate and the Speaker of the Assembly and filed with the Secretary of the Senate and the Clerk of the Assembly.

3. The Joint Conference Committee may authorize a subcommittee or subcommittees, whose members shall be separately appointed by the Temporary President of the Senate and the Speaker of the Assembly, to assist in its efforts at resolving such differing provisions.


4. The deliberations of such Committee on Conference and/or any subcommittee(s) thereof shall be open to the public in accord with the Open Meetings Law.

5. The Temporary President of the Senate and the Speaker of the Assembly shall designate employees of the Senate and the Assembly to serve as staff for the committee and/or subcommittee(s).

Whereas, on March 11, 2013 Temporary Presidents of the Senate Dean G. Skelos and Jeffrey Klein and Speaker of the Assembly Sheldon Silver executed a Joint Certificate convening a Joint Conference Committee to resolve differences between similar legislation adopted by each house of the Legislature relating to the 2013-2014 State Budget; and

Whereas, the resolution of differences between such legislation requires an additional extension of the time for deliberations of such Conference Committee for a period of one (1) day, beginning March 19, 2013 and ending at midnight on March 19, 2013;

Now, therefore, Dean G. Skelos and Jeffrey Klein, as Temporary Presidents of the Senate, and Sheldon Silver, as Speaker of the Assembly, hereby amend clause "2" in the Joint Certificate to read as follows:

2. Such Committee on Conference shall be convened as soon as reasonably practicable and shall be dissolved not later than the earlier of the filing of a report pursuant to Joint Rules II and III, or by midnight on March 19, 2013, unless extended by written notice signed by the Temporary President of the Senate and the Speaker of the Assembly and filed with the Secretary of the Senate and the Clerk of the Assembly.

**Pursuant to Joint Rules II and III of the Permanent Rules of the Senate and the Assembly**

**Whereas, on March 11, 2013 Temporary Presidents of the Senate Dean G. Skelos and Jeffrey Klein and Speaker of the Assembly Sheldon Silver executed a Joint Certificate convening a Joint Conference Committee to resolve differences between similar legislation adopted by each house of the Legislature relating to the 2013-2014 State Budget; and**

**Whereas, on March 18, 2013 Temporary Presidents of the Senate Dean G. Skelos and Jeffrey Klein and Speaker Sheldon Silver executed an Amendment to the Joint Certificate originally executed on March 11, 2013 to continue the time for deliberations of such Conference Committee through midnight on March 19, 2013; and**

**Whereas, the resolution of differences between such legislation requires an additional extension of the time for deliberations of such Conference Committee for a period of one (1) day, beginning March 20, 2013 and ending at midnight on March 20, 2013;**

**Now, therefore, Dean G. Skelos and Jeffrey Klein, as Temporary Presidents of the Senate, and Sheldon Silver, as Speaker of the Assembly, hereby amend clause "2" in the Joint Certificate, as amended, to read as follows:**

2. Such Committee on Conference shall be convened as soon as reasonably practicable and shall be dissolved not later than the earlier of the filing of a report pursuant to Joint Rules II and III, or by midnight on March 20, 2013, unless extended by written notice signed by the Temporary Presidents of the Senate and the Speaker of the Assembly and filed with the Secretary of the Senate and the Clerk of the Assembly.
