Dear Ms. Sassower,

I write in response to your email of July 24 at 3:22 p.m.

Attorney General Underwood will not be appearing for the argument on your TRO. As I previously informed you, any oral arguments in the case will be handled by me.

I will not respond to document requests at the TRO argument. The appellate level is too late for document requests. Further, I doubt that any such "findings of fact and conclusions of law" exist.

In any event, the burden of establishing entitlement to emergency relief rests on you -- as plaintiff, appellant, and movant. Your unilateral attempt to delay the TRO argument undercuts any claim of immediate and irreparable injury.

I stand by the content of my July 23 letter.
