You have posted three "Nov. 4" submissions from me. In fact, I furnished only the first and third submissions on November 4th.

Your first posted submission for me, under my name, "Elena Sassower", is a pdf of my December 31, 2015 letter to then Chief Judge Nominee/Westchester District Attorney DiFiore. This, however, is only HALF of what I handed up PRIOR to beginning my testimony at the November 4, 2019 hearing. Missing is my letter to the editor of the New York Law Journal, printed on August 21, 2019, entitled "A Call for Scholarship, Civic Engagement & Amicus Curiae Before the NYCOA" – four copies of which I simultaneously handed-up with the four copies of my December 31, 2015 letter to Chief Judge DiFiore.

Your third posted submission from me, identified as "Addendum 3", is, in a <u>single</u> pdf, eight of the nine separate pdfs I had e-mailed you on November 7th – 8th – these nine pdfs comprising <u>ALL the submissions I had made to the Commission on November 4th</u>. However, your consolidated pdf does NOT begin with the first of my separate pdfs – my August 21, 2019 <u>New York Law Journal</u> letter. Rather, it begins with my second pdf – my December 31, 2015 letter to Chief Judge DiFiore, followed by the other seven pdfs. In other words, now, <u>for a second time</u>, you have omitted my August 21, 2019 New York Law Journal letter.

As for your second posted submission from me, identified as "Addendum", it is the pdf I had e-mailed you, on November 5th, consisting of an inventory of the EVIDENCE I had furnished to the three prior "force of law" compensation commissions/committee, to be recovered by the Commission, in substantiation of my November 4th testimony.

To assist the Commission in rectifying its peculiar omission of my August 21, 2019 New York Law Journal letter, attached is the same pdf as I e-mailed on November 7th.
