I am hereby acknowledging your request dated July 14, 2016 to inspect records.

This office will make every effort to find the information you are seeking and provide it to you promptly. Some information is not releasable, and sometimes the information may not exist. In accordance with the Public Officers Law, we will advise you within the next five business days whether your request for information will be granted, denied, granted in part, or if we will need more time not to exceed 20 days to respond to your request. At that time, we will inform you as to whether the materials you have requested will be made available to you and when. Public Officers Law provides for the information to be made available, unless it is denied, within a reasonable time frame.

For paper copies more than four pages, there is a charge of \$.25 per page. Information is not always available electronically at this point. However, if information is available electronically on disk the charge is \$2.00. We will notify you of any amount due upon determination that the records are available.
