Dear Ms. Sassower:

This is to acknowledge receipt of your requests for information to the Chautauqua County Records Access Officer dated July 14 and August 8, 2016 with respect to the above referenced matter.

The County is authorized to collect fees for copies of documents provided under the Freedom of Information Law. The usual fee is \$0.25 per copied page or the actual cost of reproducing any other record and is payable upon receipt of any documents provided. The Freedom of Information Law also stipulates that certain information can be denied, however, the County is required to advise you of your rights to appeal such denials. If you choose to appeal a denial of information, you must do so in writing within thirty (30) days of receipt of such denial. The appealing authority is Vincent W. Horrigan, County Executive, 3 N. Erie Street, Mayville, NY 14757. Your appeal must state the date of the denial, the information requested, the information denied, and the reason for the denial.

This is not a denial of your request. Due to the broad scope of your request, we expect to provide a response on or before August 31, 2016.

Pursuant to the Freedom of Information Law [Public Officers Law, VI], request is made for records reflecting:

(1) the yearly salary of the county's district attorney, and, additionally, his/her yearly other "compensation and non-salary" benefits, such as pension, health insurance, etc.:

as of January 1, 2016 – and any change as of April 1, 2016; as of January 1, 2015 – and any change as of April 1, 2015; as of January 1, 2014 – and any change as of April 1, 2014; as of January 1, 2013 – and any change as of April 1, 2013; as of January 1, 2012 – and any change as of April 1, 2012; as of January 1, 2011 – and any change as of April 1, 2011; as of January 1, 2007 – and any change as of April 1, 2007;
```

(2) the yearly salaries and other "compensation and non-salary benefits" of the county's other full-time elected officers, excepting state-paid judges, for 2007 and for each year from 2011 to 2016;

Additionally, <u>for counties with populations under 40,000</u>, request is made for records, including minutes, notes, and videos of relevant county board and committee meetings, showing:

- (i) the date the county board designated the office of district attorney as full-time and the reasons therefor:
- the salary and other "compensation and non-salary benefits" of the part-time district attorney immediately prior to the change-over to full-time district attorney;

- (iii) the salary that the board determined for the county's first full-time district attorney and his/her other "compensation and non-salary benefits" and the basis for each;
- (iv) any subsequent changes the board made to the salary and other "compensation and non-salary benefits" of the county's full-time district attorney and, in particular, the date it made the district attorney salary equal to that of its county judges and the basis for each.

Pursuant to Public Officers Law §89.3, your response/acknowledgment is required "within five business days" of your receipt of this request. I would appreciate if you e-mailed it to me at elena@judgewatch.org.
