This responds to your frivolous, time-delaying February 3<sup>rd</sup> denial of my January 30<sup>th</sup> appeal on grounds that “a copy of the denial and a copy of all other communications between the parties relating to the request” was not “attached” and your false assertion that my “appeal does not specify why [I] claim the underlying denial was erroneous”.

First, my appeal furnished you with the ORIGINAL January 28<sup>th</sup> denial and the ORIGINAL other communications – ALL on the e-mail chain beneath the appeal. Above are the requested “attached” “copies”, including of your February 3<sup>rd</sup> denial. The ORIGINALS are on the e-mail chain below.

Second, my appeal specified its grounds, as follows:

“The basis of the appeal is that if the Senate ‘does not have possession of such record(s) or that such record(s) cannot be found after diligent search’ – neither of which Secretary of the Senate Paulino states – I am entitled to a certification thereof (Public Officers Law

§89.3(a) – and, additionally, to specification as to which Senate Rule would exempt the requested records from disclosure (Public Officers Law §87.2).”

**TO: Senate FOIL Appeals Officer/Senate Majority Counsel**

Pursuant to §9 of the Senate's "[Rules and Regulations Relating to the Public Inspection and Copying of Records](#)", I hereby appeal from the below January 28, 2025 e-mail of Senate FOIL Officer/Secretary of the Senate Alejandra Paulino, ESQ., denying my [January 21, 2025 FOIL request](#) for "The Salary Plans of SUNY, CUNY, & the Board of Regents Pursuant to Executive Law §169.3" by purporting that the requested records "if the records even exist, are not subject to disclosure pursuant to Senate Rules".

The basis of the appeal is that if the Senate "does not have possession of such record(s) or that such record(s) cannot be found after diligent search" – neither of which Secretary of the Senate Paulino states – I am entitled to a certification thereof (Public Officers Law §89.3(a) – and, additionally, to specification as to which Senate Rule would exempt the requested records from disclosure (Public Officers Law §87.2).

Tellingly, Secretary of the Senate Paulino's e-mail does not inform me of my right of appeal, as is required by §7 of the Senate's "Rules and Regulations Relating to the Public Inspection and Copying of Records".
