The records you are requesting are records of the court. Please be advised that the Office of Court Administration does not maintain court records, nor are court records subject to FOIL. See Public Officers Law § 86.

Rather, access to court records is governed by section 255 of the Judiciary Law, and the custodian of court records typically is the clerk of the court or county clerk where the proceedings were handled. Additional information regarding access to court records is available at the following link: http://www2.nycourts.gov/foil/CourtRecords.shtml

You should direct a section 255 request to the clerk where your case was handled. The request should identify the specific records sought, to permit the clerk to conduct a search, determine what responsive records exist, and assess the search, copy, and certification fees, consistent with CPLR Article 80. Section 255 does not require the clerk to conduct case search research, compile information, or create a record.

The video of the Court of Appeals' oral argument yesterday of *Cuomo v. COELIG* (APL-2024-76) is not yet available. However, to the best of my recollection, I believe it was Associate Justice Halligan who stated that the Court had never considered a JCOPE case.
