Dear Ms. Sassower:

As Chair of the Grievance Committee for the Tenth Judicial District, pursuant to Rule 1240.7(e)(3) of the Rules of Attorney Disciplinary Matters (22 NYCRR part 1240), I am responding to your recent correspondence dated September 24, 2021, seeking reconsideration of the Committee's determination not to open an investigation against a Nassau County attorney.

In your complaint dated April 8, 2021 (received by this Committee on August 25, 2021), you alleged, among other things, that the attorney's conduct in representing the defendants in the cases you referenced was, in essence, improper and/or unethical. You further alleged that the Judge involved in these cases also engaged in improper and/or unethical conduct. As you were advised by staff counsel in our letter dated September 15, 2021, the Committee cannot assist you at this time. Your dissatisfaction with the conduct of the attorney involves issues for which legal remedies are available. Your complaint regarding the Judge's alleged misconduct should be addressed to the New York State Commission on Judicial Conduct at 61 Broadway, Suite 1200, New York, New York 10006, Telephone No. (646) 386-4800, cjc@cjc.ny.gov.

Nothing in your recent submission (dated September 24, 2021) gives the Committee cause to alter its prior determination.
