Dear Ms. Sassower:


This letter is in response to your request for reconsideration previously sent to all three Chairpersons of the three Judicial District committees. Because the matter had been originally transferred to the Seventh Judicial district for my review, the Chairperson of the Seventh District committee was responsible for handling your request, and the Chairpersons of the other two district declined to become involved.

I have been directed by the Seventh District Chairperson, Steven V. Modica, Esq., to inform you that he has denied your request for reconsideration pursuant to 22 NYCRR 1240.(3), and without referral to the full committee. The denial is based upon his review of your submission for reconsideration, and of the underlying complaints you previously made which I reviewed, including your complaint of November 9, 2021; your complaint of April 3, 2021, referenced therein; Ms. Merker's letter of September 15, 2021; Ms. Sheridan's letter of October 18, 2021; and Chairman Glover's letter of the same date.

The denial of your request for reconsideration was based upon the determination that the process engaged in by the parties you complained of was proper pursuant to the Rules of the Court, and that you are not entitled to the relief you sought. See 22 NYCRR 1240.7(e)(3).

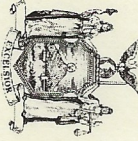
Accordingly, I have been directed to advise you that your request for reconsideration is denied, and the matter will remain closed.
