This follows my phone conversation a short time ago with Kasia Williams, a secretary at the Appellate Division, Fourth Department’s Grievance Committee for the Eighth Judicial District (716-845-3630), who told me that there was no e-mail or other electronic means for my filing of my complaint against Eugene Fahey, Esq.

In other words, a year and a half after my [October 26, 2023 e-mail](#) brought to the attention of Chief Administrative Judge Zayas that the Appellate Division, Fourth Department has excepted itself from the “uniformity” of the other Appellate Divisions in NOT having any e-mail address or system for electronic filing of complaints, the situation remains unchanged.

As I have already e-mailed you my identical complaints against the five lawyer-members of the Commission on Legislative, Judicial and Executive Compensation, I would appreciate if you would forward this e-mail with my complaint against the Commission’s lawyer-Chair Fahey to Fourth Department Attorney Grievance Committee Chief Counsel Cydney Kelly, so that she has it. The original complaint form will be sent by regular mail to the Eighth Judicial District Attorney Grievance Committee in Buffalo.
