<u>Summary of Complaint</u>

possible, such as what happened, where and when; the names of witnesses; who said what to whom, and in what tone of voice; etc. *

The FCLU and I have been investigating Judge Hoffman for seven years. We have made repeated complaints, which you have totally ignored. We request and require you again now to fulfill your duty as a watchdog body and take the necessary action to remove this judge from the bench. Misconduct includes repeated abuse of power; tortious interference; harassment; unjustified closure of his court room; illegal use of his power to punish a parent for declining to be vaccinated for covid by removing his parental access to a four-year old child; fraud upon the court; unacceptable delays; negligence; improper temperament; improper relationships with other attorneys; sexual harassment of his own court attorney. As evidence there is the attached report, including numerous hyperlinks to trusted sources; an official transcript for the February 7, 2023 court hearing where he defamed me and the FCLU, failed to deal with urgent matters related to the welfare of a child, and illegally closed the courtroom. Also attached is a Litigation Hold letter sent by my attorney, which led Hoffman to recuse himself from the Boyajian case. If the CJC fails to take any action with this plethora of evidence against this judge, we will add you to the list of Defendants in this matter. Please do your job and your duty.
