The <u>December 4, 2023 "Report on Judicial Compensation"</u> by the (3rd) Commission on Legislative, Judicial and Executive Compensation is "a fraud on the People of the State of New York and a grand larceny of taxpayer monies" – so-demonstrated by <u>CJA's January 18, 2024 Opposition Report</u>.

The sole non-lawyer member of that seven-member Commission is Rockefeller Institute of Government President Robert Megna – and the particulars of his conflicts-of-interest, requiring him to have disqualified himself, are detailed at pages 10-13 of the Opposition Report. These include my November 2, 2021 complaint against him to you and my July 11, 2013 complaint against him to predecessor Inspector General Catherine Leahy Scott and my August 31, 2020 complaint and June 27, 2013 complaint against him to JCOPE – all exhibits to the June 6, 2022 verified petition in CJA v. JCOPE, et al., whose three-volume record on appeal and appellants' brief I furnished to the Commission on Legislative, Judicial and Executive Compensation, when I testified at its October 13, 2023 hearing, designating the case as Exhibit B to the corruption infesting the judiciary (VIDEO, at 2hrs/31mins.; Tr. 101-108).

I have already filed a <u>conflict-of-interest/corruption complaint with the Commission on Ethics and Lobbying in Government (COELIG)</u> against all seven members of the (3rd) Commission on Legislative, Judicial and Executive Compensation – and have filed complaints against each of its six attorney-members with the Appellate Division Attorney Grievance Committees. <u>AGC-4 (Fahey)</u>; <u>AGC-3 (Egan)</u>; <u>AGC-2 (Blank)</u>; <u>AGC-2 (Fontaine)</u>; <u>AGC-2 (Weinstein)</u>; <u>AGC-1 (Kovner)</u>.

As Rockefeller Institute of Government is part of SUNY, which is within your jurisdiction as a "covered agency", I herewith file this complaint against Mr. Megna, as member of the (3rd) Commission on Legislative, Judicial and Executive Compensation and as Rockefeller Institute of Government president, in which capacity, to cover-up his own corruption as New York State budget director and otherwise, he has perpetuated and colluded in its non-existent scholarship – and the non-existent scholarship of other SUNY entities – with respect to the EVIDENCE he has had, for years, as to the unconstitutionality, unlawfulness, and larceny of the state budget and the "force of law" commission/committee scheme to raise salaries of New York's corrupt and conspiring highest constitutional officers.

Although not required by instructions on your Inspector General website – or by <u>Executive Law Article 4-A</u> – I readily swear to the truth of this complaint under penalties of perjury – and state, in the words required by Albany District Attorney Soares' complaint form for his Public Integrity Unit:

"I understand that any false statements made in this complaint are punishable as a Class A Misdemeanor under Section 175.30 and/or Section 210.45 of the Penal Law."
