Attached is the written testimony I read at today's hearing, excepting the endnotes, which I did not read.

The only correction I have made to the written testimony is as to the amount of Vice-Chair Austin's and Commissioner Carni's financial interests in the judicial pay raises that underlie my July 8, 2022 complaints. My August 4<sup>th</sup> letter, about which I was testifying, put the amount of their claw-back liability at "approximately three quarters of a million dollars each" (at p. 6), not the "approximately half a million dollars each" I misstated in testifying. I have, therefore, made that correction – and I think it is the more accurate estimation of the cumulative amount of judicial pay raises that Vice-Chair Austin received from April 2012 to January 2022 and Commissioner Carni received from April 2012 to February 2022, when they respectively left the bench.
