In response to your appeal of February 8, 2025, I am forwarding you a corrected chart of "matters incepted ... in 2023" that now includes information mistakenly omitted from the chart the Commission sent you by electronic mail on January 10, 2025, in response to your original November 15, 2024 FOIL request. For entries marked "N/A," please note that the information requested is exempt from public access because either:

- 1. The Commission cannot confirm or deny the existence of an investigation: whether an investigation exists is deemed confidential under Executive Law § 94(11)(b). Thus, any record relating to an investigation is exempt from disclosure pursuant to Public Officers Law § 87(2)(a); or
- 2. The material sought is specifically exempted from disclosure by statute. Executive Law § 94(10)(m) prohibits the release of information of the kind you seek, as when "the Commission determines a complaint or referral lacks specific and credible evidence of a violation of the laws under its jurisdiction, or a matter is closed due to the allegations being unsubstantiated prior to a vote by the [C]omission, such records and all related material shall be exempt from public disclosure under [A]rticle [S]ix of the [P]ublic [O]fficers [L]aw."

In summary, the Freedom of Information Law provides that documents "specifically exempted from disclosure by state or federal statute" are not subject to its disclosure requirements. (See, Public Officers Law § 87(2)(a).)

I trust this clarification addresses the omissions in the initial chart the Commission's Records Access Officer provided you that you noted in your appeal. To the extent any information has been withheld from public inspection and copying by the Commission in its response to your request, I determine that the Commission acted and continues to act appropriately and in accordance with the protections afforded under Section 87 of the Public Officers Law.

TO: COELIG APPEALS OFFICER - Presumably General Counsel Keith St. John

I hereby appeal from COELIG's below <u>January 10, 2025 FOIL response</u>, with the above-attached <u>chart</u>, to my <u>November 15, 2024 FOIL request</u> entitled "COELIG's 2023 Annual Report – & its Chart of 'matters incepted...in 2023".

The basis of the appeal is that the attached chart is not responsive, at all, to five of my six records requests – and as to the one it is responsive, request #3, it is incomplete and peculiar.

If, by the failure to address requests #1, #2, #4, #5, and #6, COELIG is implicitly denying me access to records I am seeking, I hereby appeal that denial, for which no explanation is given. If, on the other hand, COELIG is implying that it "does not have possession" of the requested records or that such records

"cannot be found after diligent search", I request a certification of same pursuant to <u>Public Officers Law</u> §89.3(a).

As to your chart responding to request #3 for records reflecting "information pertaining to the missing 106 entries, to wit, 'Reference ID', 'Agency', 'Law', 'Nature of Allegation', 'Status', and 'Closed Date'", the new chart you have furnished:

- (1) peculiarly leaves blank the "Agency" field for the following "Reference ID" numbers: 23-003, 23-009, 23-020, 23-028, 23-034, 23-035, 23-036, 23-038, 23-039, 23-053, 23-064, 23-065, 23-066, 23-068, 23-069, 23-084, 23-096, 23-097, 23-098, 23-115, 23-116, 23-119, 23-122, 23-123, 23-125, 23-128, 23-133, 23-136, 23-137, 23-146, 23-148, 23-150;
- (2) peculiarly removes the "Agency" field for the following "Reference ID" numbers which had been identified in the chart from COELIG's 2023 Annual Report: 23-008, 23-016, 23-025, 23-031, 23-040, 23-100, 23-106, 23-107, 23-108, 23-109, 23-113, 23-118;
- (3) peculiarly removes the designation "N/A" in the "Agency" field for the following "Reference ID" numbers that had appeared in the chart from COELIG's 2023 Annual Report, leaving the field blank: 23-037, 23-049, 23-061, 23-062, 23-070, 23-072, 23-073, 23-076, 23-082, 23-088, 23-094, 23-103, 23-105;
- (4) changes the designation of the "Agency" field that had appeared in the chart from COELIG's 2023 Annual Report for the following "Reference ID" numbers: 23-029 (changed to JCOPE from COELIG); 23-030 (changed to JCOPE from COELIG); 23-086 (changed to JCOPE from COELIG);
- (5) skips "Reference ID" number 23-017.

I am entitled to rectification of these deficiencies or clarification/certification with respect thereto.
