I have received and reviewed your January 21, 2025 Appeal of a December 23, 2024 response from the Records Access Officer for the Commission on Ethics and Lobbying in Government (the "Commission") concerning your FOIL request captioned above. In response to your original FOIL request for "any cumulative tally of the hourly per diems paid **to date** to the Commissioners including as supplemented, retroactively, to April 1, 2024" (emphasis added), the Commission, by its Records Access Officer, provided you with documents responsive to your November 15, 2024 request, through the period you specified: April 1, 2024—November 15, 2024.

Insofar as your appeal does not challenge the legal sufficiency of the record production afforded you--per your written request--by the Commission's Records Access Officer but, instead, asks for *additional records outside of the period you initially requested*, I determine that your appeal should be dismissed, as the Commission's December 23, 2024 response to you did not constitute a denial of your November 15, 2024 FOIL request. Nor do you assert such a denial in your Appeal. Your remedy for accessing any additional documentation of hourly per diem payments made to members of the Commission, covering a period that extends beyond that of your initial records access request, is to submit a new FOIL request for the additional records you now seek that were not included in your description of records requested in your November 15, 2024 electronic correspondence.

This constitutes my determination of your January 21, 2025 Appeal.

Your <u>2023 Annual Report</u>, released on <u>June 24, 2024</u>, states that among COELIG's "Accomplishments" and "significant milestones" is "Posting Commissioner Per Diem Allowances" (at p. 22). It does not

provide any figures, but instead furnishes a <u>link to where they are posted on COELIG's "Pressroom"</u> <u>website</u>. From the nine entries currently posted, it is impossible to ascertain the cumulative figure either for hourly *per diem* payments made in 2023 or of work done in 2023, for which hourly *per diem* payments were made. These nine entries are: .

"Oct 2023-Mar 2024 Commissioner Per Diems" (Paid-May 22, 2024)	\$15,976.35
"Oct. 2023 – March 2024 Commissioner Per Diems" (Paid-May 22, 2024)	\$15,976.61
"Jan – April 2024 Commissioner Per Diems" (Paid-April 10, 2024)	\$36,240.20
"Nov 2023- March 2024 Commissioner Per Diems" (estimated)	\$8,371.56
"Oct – Dec 2023 Commissioner Per Diems" (Paid-Dec 20, 2023)	\$37,895.82
"Sept – Nov 2023 Commissioner Per Diems" (Paid-Nov 2023)	\$23,612.95
"July – September 2023 Commissioner Per Diems"	\$18,340.76
" <u>Apr – June 2023 Commissioner Per Diems</u> "	\$45,982.09
"FY 2022-23 Commissioner Per Diems" (Paid-FY 2022-23)	\$83,946.11

It appears from this tally – and omitting what appears to be a redundant entry (differing by 26 cents) and an estimated entry, that the amount is: \$261,994.54.
