On Friday, March 11, 2022, after sending the below e-mail concerning (1) the NYS budget; (2) "ethics reform"; and (3) the 2022 elections, I received an almost instantaneous <u>automated acknowledgment</u> from the <u>Times</u> Editorial Board, stating:

"Questions beyond the Opinion section? ... Tips can be shared at <u>nytimes.com/tips</u>."

This I am now doing, by this e-mail to the e-mail address therein indicated: <u>tips@nytimes.com</u> – as I have yet to receive any other response from the Editorial Board – and no responses from new Albany Bureau Chief Ferre-Sadurni, to whom my March 11, 2022 e-mail was addressed, or from the other indicated recipients: Albany correspondent Grace Ashford, Metro, and former Albany Bureau Chief Jesse McKinley.

However, with regard to the further instruction on the Editorial Board's automated acknowledgment:

"To email a reporter about a story idea or to provide feedback on a story, click on the reporter's byline and choose 'email author.' More contacts for The New York Times <u>can be found here</u> and <u>additional</u> <u>FAQs here</u>",

I have NO idea what you are talking about – and re-subscribed to the <u>Times</u>, which I had discontinued last June, for the SOLE purpose of ascertaining whether there was ANY change from what I had previously seen, namely, that the <u>Times</u>' posting of "the reporter's byline" does NOT link to any option for "email author". Indeed, I believe the <u>Times</u> dropped that responsible, helpful, accountability feature YEARS AGO. Nor have I found ANY directory of reporters' names and e-mails – or the names and e-mails of relevant editors.

If I am mistaken, please advise. Otherwise, change your incorrect instructions.

BTW, what are the e-mail addresses for "Jim Dao and Dean Chang" who announced "<u>A Promotion for</u> <u>Luis Ferre-Sadurni</u>". Their e-mail addresses are not on the March 10, 2022 announcement – and, using the "search" feature of the <u>Times</u> website, I can barely find <u>Metro Editor James Dao</u> and cannot find, at all, Deputy Metro Editor Dean Chang, let alone their e-mail addresses.

The <u>Times</u> website – which I believe LONG AGO posted a general phone number that connected to a switchboard operator – now only has a user-friendless "customer service" number (855-698-1157) that deals with billings and subscriptions. Fortunately, I had the prior number, 212-556-1234, and upon calling it last Friday, at about 4:20 pm, got voice options enabling me to eventually connect to the Metro desk. My call was answered by Metro assistant Reagan, who stated – after checking – that she could not give me the e-mail address of <u>Nicholas Fandos</u>, who has written many of the <u>Times</u>' recent articles about the New York political scene and whose byline link identifies him as "a reporter on the Metro desk…covering New York State politics". Her stated reason was "security concerns" – and she told me the same in response to my requests for e-mail addresses for Messrs. Dao and Chang.

Apparently, however, Mr. Fandos does not himself have such "safety concerns", as I thereafter found his e-mail address on his <u>"Linked-In" webpage</u>.

I have received no response to my below November 8th e-mail, inquiring about the December 9th public hearing which you have entitled "To discuss New York State's system of ethics oversight and enforcement".

As of this date, a full week later, there is still no press release/public announcement about the hearing posted on either the Committee's website, your website, or the Senate's website, nor registration information for witnesses wishing to testify.

Please advise – and confirm that <u>the Committee's December 9th hearing</u> – unlike its <u>August 25th hearing</u> – will afford members of the public with the opportunity to testify about their direct, first-hand experiences in filing complaints with the gamut of entities comprising "New York State's system of ethics oversight and enforcement". This includes, of course:

- <u>the entity with ethics jurisdiction over New York's judges</u>: the New York State Commission on Judicial Conduct;
- <u>the entity with ethics jurisdiction over the Unified Court System's non-judges</u>: the Unified Court System's Inspector General; and
- <u>the entity with ethics jurisdiction over New York attorneys</u>: the attorney grievance committees of New York's four Appellate Divisions.

By the way, when was the last time ANY legislative committee held oversight hearings over these three ethics entities, thereafter making findings of fact and conclusions of law with respect to the testimony of members of the public – based on investigation of their substantiating documentary EVIDENCE?

If you do not already know the answer, as chair of the Senate Committee on Ethics and Internal Governance, as a member of the Senate Committee on Investigations and Government Operations, of the Senate Judiciary Committee, and of the Senate Codes Committee, you surely can obtain it – and it is your duty to do so.
