Following up our phone conversation a short time ago (315-312-1048), in which you stated that WRVO's area of coverage extends to 20 New York counties, in whole or in part, I have just discovered that I already sent you, on Friday, the story pertaining to the nominally-contested Cortland County D.A. race. It is below.

Of Cortland County's three re-election-seeking state legislators – Assemblywoman Kelles is running, unopposed, on Democratic and Working Families lines, for which she faced no primary challenge for either line, and Assemblyman Jeff Gallahan is running, unopposed, on Republican and Conservative lines, for which he faced no primary challenge for either line. Why is that? Investigative reporting is essential.

Cortland County's state legislators – and the state legislators of New York's other 61 counties – are NOT doing their jobs and are corrupt – and this is the subject of pending lawsuits, as, likewise, of fully-documented criminal and ethics complaints against them. Their \$142,000 salaries, which they procured by fraud and by obliterating ALL legislative process, are the highest in the country – on top of which they get non-salary benefits and other compensation worth tens of thousands of dollars. By comparison, the median household income in Cortland County is \$65,029.

I will send you e-mails about the completely uncontested D.A. races in Wayne, Tompkins, and Madison Counties – and the re-election-seeking state legislators of those counties.

The annual salary of Cortland County's district attorney, statutorily-linked to the annual salary of its county court judges, is \$221,100 – \$101,300 of which is the product of three "false instrument", penal law-violating commission reports. This is the subject of my above-attached fully-documented July 18, 2024 NOTICE/grand jury public corruption complaint that the two Cortland County D.A. candidates have had for weeks.

Below is my July 18th transmitting e-mail to incumbent [D.A. Patrick Perfetti](#), running on the Republican and Conservative lines, and above it, my July 24th transmitting e-mail to [D.A. Candidate Elizabeth McGrath](#), running on the Democratic and Working Families lines, requesting their responses by August 1st. I have received none.

As D.A. Candidates Perfetti and McGrath would presumably be more responsive to WRVO-Public Media, I am cc'ing them so that no time is wasted. What do they have to say about the \$221,100 Cortland County D.A. salary – and about Cortland County's three re-election-seeking state legislators, Senator Oberacker and Assembly Members Kelles and Gallahan, whose public corruption is prioritized by the July 18, 2024 NOTICE/grand jury complaint (at p. 2). Will D.A. Candidates Perfetti and McGrath disclose their political, professional, and personal relationships with these incumbent state legislators – and with the other public officers complained-against and implicated by the July 18, 2024 NOTICE/grand jury complaint?

Please call me so that we can discuss the information that Cortland County voters must have if they are to cast informed votes in the D.A. race, in the three state legislative races, and in the judicial races that are on the Cortland County ballots.

I am director and co-founder of the non-partisan, non-profit citizens' organization Center for Judicial Accountability, Inc. (CJA), which, for several decades, has documented the collusion of all three branches of our state government in the subversion and collapse of lawful, constitutional governance. New York's 62 D.A.s, whose duty it is to enforce the state's penal laws, including against law-breaking public officers, are key participants in this.

Only five of this year's 14 D.A. races are contested and, among them, your two D.A. races against incumbent Livingston County D.A. McCaffrey and incumbent Cortland County D.A. Perfetti.

The GOOD NEWS is that you can easily win – and without money – against them simply by using the bully-pulpit of your candidacies to “whistle-blow” about the public corruption involving D.A. salaries that they have each known about, perpetuated, and benefitted from since 2016. This is the subject of my below July 18th e-mail to them and their fellow 60 D.A.s. entitled “NOTICE & grand jury/public corruption complaint – Your D.A. salary increases, the judicial salary increases on which they are based, & the violations of NY penal laws by state legislators within your jurisdictions”, requesting their answers, by August 1st, to two simple questions:

- (1) whether they will be repudiating their state-mandated D.A. salary increases, paid from their county budgets, because they are based on three “false instrument”, penal law-violating commission reports increasing judicial salaries;
- (2) confirmation that they will be recusing themselves from CJA's July 18, 2024 grand jury/public corruption complaint pertaining thereto and securing an independent prosecutor.

If elected, what would your answers be? Please let me hear from you by August 1st so that, based on your answers, Livingston and Cortland county voters can be apprised as to whether write-in campaigns must be launched for suitable D.A. candidates who will abide by their duty of enforcing New York's penal laws, without fear or favor, including by recusing themselves when they are compromised by self-interest and relationships.

I am available to answer questions, including as to the particulars of my communications with D.A.s McCaffrey and Perfetti.
