Following up our phone conversation (315-470-2265) a short time ago – for which I thank you – here’s the link to the NYS comptroller’s [“Newspapers Available for Notice Publications”](#) identifying, for Cortland County, [The Post Standard](#), as one such newspaper. This is what prompted me to then search the [Syracuse.com website](#) for information as to the counties it covers and for its newsroom, but found nothing as to either.

As discussed, I reached you only because, after first calling the sole posted number for [“Contact Us”](#) – which was for “Customer Service”: 315-470-6397 – Alan from “subscription services and home delivery”, who answered my call, gave me the number that you picked up. The only e-mail address he had for news was letters@syracuse.com.

Years ago, Syracuse.com did have excellent “Contact”/staff pages, but this seems to have vanished. Here’s [the “Contact Us” of The Albany Times Union](#), which brings up a splendid menu of options under the title “Help desk”.

The e-mail you gave me for the Syracuse.com newsroom -- citynews@syracuse.com – does not befit a newspaper covering Onondaga County, let alone the adjacent counties of Oswego, Cayuga, Madison – and Cortland. More is needed.

I will cc you on my e-mail to citynews@syracuse.com for its reporting on the 2024 Cortland County elections – and next week for the 2024 Madison County elections – both counties, having D.A. elections, as you saw from [CJA’s 2024 elections webpage](#).
