I do not deem the below October 15<sup>th</sup> e-mail of Executive Director/CEO Rundlet, which I have just seen, to be an acceptable response to my below October 15<sup>th</sup> complaint to you against her. Indeed, her e-mail, which could have, but does <u>not</u>, *cc* you or anyone else, does <u>not</u> refer to the complaint, at all, and offers <u>no</u> explanation for her failure and that of her "Leadership Team" and "Management & Staff" to respond to my September 19<sup>th</sup> e-mail to them. What is their explanation?

As for my purported "outreach" for which Ms. Rundlet thanks me, this is her euphemism for my June 16, 2023 complaint against ten INN members for their knowingly false, corruption-abetting, election-rigging journalism, violating INN standards, including 501(c)(3) proscriptions on partisanship, "defrauding citizens and philanthropies into making monetary donations" and "defrauding the IRS". This she transmogrifies into permissible "editorial independence", in keeping with INN standards.

Is this your view of my painstakingly-documented June 16, 2023 complaint – and the further substantiating evidence my September 19, 2024 supplement furnished with respect to <u>New York Focus</u> and <u>Investigative Post</u>? Is it your view that INN members, who use their INN membership as a credential, including to tap into funding sources and opportunities that you facilitate, can brazenly violate INN standards, without the slightest oversight by you. What mechanisms of accountability and fidelity to ethics codes, including as to conflicts of interests, do you purport exist with respect to your INN members.

And, of course, Ms. Rundlet does not respond, at all, to the three requests for assistance presented by the June 16, 2023 complaint:

- "for assistance in securing the investigative, public service journalism that INN's ten New York members did not do and were duty-bound to have done;
- "for assistance in establishing an independent nonprofit, nonpartisan newsroom producing investigative journalism into the efficacy of safeguards against judicial misconduct, including judicial selection and judicial discipline processes – no such entity existing;
- "for assistance in bringing CJA's archive of primary-source, documentary evidence of press performance into scholarship".

What are your responses to these three requests?

Please immediately forward this e-mail to ALL members of INN's Board of Directors and relevant members of the "Standards Task Force & Advisory Groups" – and advise as to your answers as soon as possible.
