Two days ago, you published, as your "EDITOR'S PICK", an article by reporter Justin Sondel entitled "[Race for district attorney may be Western New York's most expensive](#)", focused on the money raised and spent by Democratic Acting D.A. Keane and Republican Challenger Gardner for the Erie County D.A. race. **How is this article of any use to voters in making an informed decision about these two candidates – including by its repetition of their campaign claims, uncritically as to Keane and essentially so as to Gardner.**

When Mr. Sondel was assigned the story that would be the "EDITOR'S PICK", was he apprised of my below August 8<sup>th</sup> e-mail to you, to which both Keane and Gardner were cc'd? Was he told that the evidence and questions it furnished – if reported – made the candidates' subsequent fund-raising and campaign ads superfluous deceptions because their candidacies were torpedoed by the evidence and questions, exposing them as corrupt and collusive with each other in abetting corruption, starting with the Erie County D.A. salary.

Suffice to note that based on prior [Buffalo News](#) articles, you knew that Keane's direct financial interest in the above July 18, 2024 grand jury/public corruption complaint, upon which my August 8<sup>th</sup> e-mail to you rests, extended beyond his own D.A. salary to that of his wife, a Supreme Court justice since January 2018 and, since January 2024, an Appellate Division, Fourth Department associate justice ("[Judge from Orchard Park promoted to state Appellate Division](#)" (Jan. 4, 2024/Stephen Watson); "[Keane gets Democratic endorsement for Erie County DA](#)" (Nov. 21, 2023/Charlie Specht); "[Veteran prosecutor Christopher Belling seeking Democratic endorsement for Erie County DA](#)" (Nov. 20, 2023/Charlie Specht).

To enable you to belatedly investigate and report on the story that was your duty to investigate and report 2-1/2 months ago, when I furnished you with my below August 8<sup>th</sup> e-mail – and then sent you comparable e-mails pertaining to the D.A. races:

Candidates Keane & Gardner, its 15 State Legislators, Four Uncontested for Re-Election, & its Four Uncontested Supreme Court Judgeships”. Is there anything there that you deny, dispute, or deem not essential to being reported or germane to such candidate endorsements as you may be making?

This follows the two messages I sent you, via [your D.A. campaign facebook page](#), on July 19<sup>th</sup> and July 21<sup>st</sup>, requesting your e-mail address, without response. Fortunately, I was able to discover an e-mail address for you on the Office of Court Administration webpage of your attorney registration.

I am director and co-founder of the non-partisan, non-profit citizens' organization Center for Judicial Accountability, Inc. (CJA), which, for several decades, has documented the collusion of all three branches of our state government in the subversion and collapse of lawful, constitutional governance. New York's 62 D.A.s, whose duty it is to enforce the state's penal laws, including against law-breaking public officers, are key participants in this.

Only five of this year's 14 D.A. races are uncontested, and, among them, your D.A. race against Erie County Acting D.A. Michael Keane – the hand-picked successor of former Erie County D.A. John Flynn.

Last week, I sent Acting D.A. Keane – and all 61 of New York's other D.A.s and acting D.A.s – the above three attachments by the below July 18<sup>th</sup> e-mail entitled "NOTICE & grand jury/public corruption complaint – Your D.A. salary increases, the judicial salary increases on which they are based, & the violations of NY penal laws by state legislators within your jurisdictions", requesting their answers, by August 1<sup>st</sup>, to two simple questions:

- (1) whether they will be repudiating their state-mandated D.A. salary increases, paid from their county budgets, because they are based on three "false instrument", penal law-violating commission reports raising judicial salaries;
- (2) confirmation that they will be recusing themselves from CJA's July 18, 2024 grand jury/public corruption complaint pertaining thereto and securing an independent prosecutor.

If elected, what would your answers be? Please let me hear from you by August 1<sup>st</sup> so that, based on your answers, Erie county voters may be apprised as to whether a write-in campaign must be launched for suitable D.A. candidates who will abide by their duty of enforcing New York's penal laws, without fear or favor, including by recusing themselves when compromised by self-interest and relationships.

I am available to answer questions, including as to the particulars of my communications with former Erie County D.A. Flynn and his predecessor Acting D.A. Michael Flaherty.
