The confirmation hearing is scheduled to begin at 2:00 p.m. on Tuesday, September 7th, in the Hamilton Room (B), 2nd Floor of the Legislative Office Building.

It is our hope to make Senate confirmation of Justice Howard Levine more than the "rubber stamp" it presently is. With Law Journal coverage of our challenge to Justice Levine's elevation to this State's highest court, we may yet "reinvent democracy".
