**Subject: Are CPB Inspector General Howell & Deputy Richardson Aware of Your Dec 5th E-Mail -- & Is It Acceptable to Them?**

TO: Helen Mollick, Counsel to the CPB Inspector General & Assistant Inspector General for Investigations

This replies to your below December 10<sup>th</sup> e-mail to my December 5<sup>th</sup> e-mail, also below.

Your December 10<sup>th</sup> e-mail misleadingly describes my complaints against NPR and PBS as about “their ‘suppression’ of news stories” – and goes downhill from there.

First, your e-mail does NOT respond, at all, to my questions:

- (1) “have [my] complaints [vs NPR and PBS] been reviewed by CPB Inspector General Kimberly Howell and Deputy Inspector General William Richardson III”?
- (2) “where can I find the amount of federal monies that CPB has given to NPR and PBS as ‘Community Service grants’, etc. over the past ten years? Does CPB provide this information to Congress in annual reports – and, if so, where can I find these reports and the congressional committees to which they were furnished?”

What are your answers to these four questions?

Second, inasmuch as your e-mail states “the Office of the Inspector General (OIG) occasionally refers complaints involving program content and presentation to one or both of the public editors [of NPR and PBS]”, here are two OBVIOUS questions. Why have my complaints not been similarly referred to the NPR and PBS public editors? What was the criteria for OIG referral of those other complaints, not here met?

Third, inasmuch as your e-mail states “Neither we nor CPB has any oversight authority or responsibility over either of the public editors” and “oversight or investigation of the public editors and content at local

public media stations are not within the purview or authority of the CPB OIG”, here are three further OBVIOUS questions. Who has “oversight authority or responsibility” over the completely MIA public editors of NPR and PBS? – and, additionally, over their completely MIA management and boards of directors? Are you saying that their TOTAL nonfeasance with respect to fully-documented complaints of fraudulent, corruption-abetting, election-rigging journalism can simply be ignored by CPB and its OIG, as you do by your kiss-off final sentence: “We consider this matter closed and will take no further action?”

Please advise, as soon as possible. TIME IS OF THE ESSENCE.

Dear Ms. Sassower,

As I promised in our phone call on November 4, 2024, we have reviewed the materials that you linked for us, detailing your complaints about New York public radio and public television stations, their “suppression” of news stories, your complaints about those stations to both the NPR and PBS Public Editors, and your subsequent complaints about both public editors.

After our review, we stand by the substance of our original response to you. While the Office of the Inspector General (OIG) occasionally refers complaints involving program content and presentation to one or both of the public editors, this office is completely independent from both of them. Neither we nor CPB has any oversight authority or responsibility over either of the public editors. Also, CPB, NPR, and PBS are all independent non-profit public media organizations, each operating independently, each with its own Board of Directors and management.

It is clear from your messages and follow-up that your concerns are strongly held and expressed; unfortunately, oversight or investigation of the public editors and content at local public media stations are not within the purview or authority of the CPB OIG.

We consider this matter closed and will take no further action.

Dear Ms. Sassower,

We have received and reviewed your voicemail from last Thursday, October 24, 2024, left on the voicemail system at the Office of Inspector General for the Corporation for Public Broadcasting.

Your message states that you have lodged repeated complaints with the management and leadership of both NPR and PBS, without receiving any response, and that you would like to talk about the Public Editors at both NPR and PBS.

While my office sometimes refers matters involving program content to both of those public editors, this office does not have any oversight responsibility or authority over either of those public editors or NPR or PBS. A phone call to discuss either of them would serve no purpose. Our mandate is to provide oversight of the Corporation for Public Broadcasting's programs and operations. This primarily involves performing audits and evaluations of stations that receive CPB Community Service grants. Those grants make up 75% of the funds CPB receives.

Your message was not clear on whether you had or had not already contacted the NPR and PBS Public Editors. If your complaint is about NPR and PBS management or editorial responsibilities, you may want to consider direct contact with them at <https://www.pbs.org/publiceditor/> and <https://www.npr.org/sections/publiceditor/>
