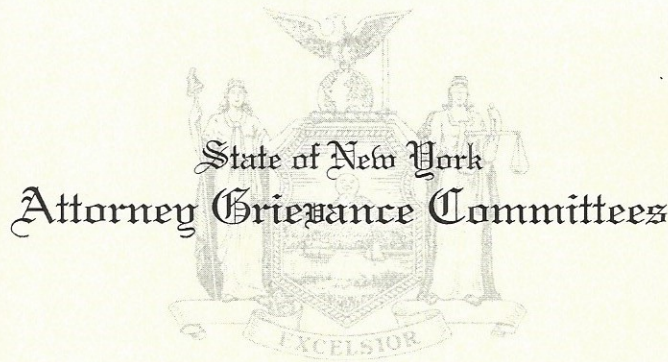

Please be advised that we have completed our review and evaluation of your complaint against the above-referenced attorney. A partial copy of same will be provided to Mr. Dingeldey by copy of this letter. Please note we are not forwarding a complete copy of the enclosures due to the voluminous size of the contents. Should Mr. Dingeldey wish to be provided a complete copy, he may contact this office directly with his request.


The focus of your complaint concerns an allegation that Mr. Dingeldey, Jr., an attorney for the Brighton Central School District, engaged in some form of an improper conflict of interest during the pendency of your legal action. Based on our review of the materials you submitted with your complaint, we have determined that there is insufficient evidence which would substantiate your contention that a conflict of interest exists.

Please understand that absent actual evidence of unethical conduct, this Grievance Committee cannot justify further review of this matter, much less the taking of disciplinary action.

Under the authority of the Chief Counsel for the Attorney Grievance Committee, Cydney A. Kelly (*See: 22 NYCRR §1020.5 and §1240.7 [(b)][4]*), this grievance has been reviewed with staff counsel and, after a careful examination of the matter, it has been determined that this grievance be dismissed.

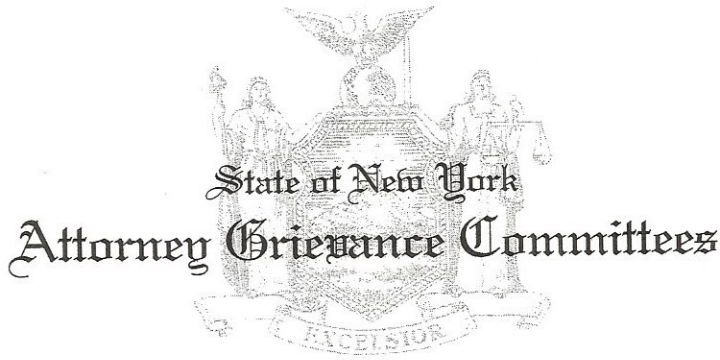
