Pursuant to [FOIL](#) – Public Officers Law §89.4(a) – I hereby appeal the below November 15th response to my below October 10th FOIL request -- & specifically, as to item 4, for:

“4. records reflecting why the Commission on Legislative, Judicial and Executive Compensation has a non-governmental **.org** website, *to wit*, www.nyscommissiononcompensation.org, and a non-governmental [gmail.com](mailto:nyscompensation@gmail.com) e-mail address, *to wit*, nyscompensation@gmail.com.”

Your response, which is not by a person identifying him/herself or who purports to be your FOIL records access officer, is that “the Commission has conducted a diligent search of available records and has not located any records responsive to your request”.

If, upon this appeal, further “diligent search” does not locate records responsive to item 4, I request certification pursuant to Public Officers Law §89.3(a), which reads:

In response to your request for “filings thereof with the Secretary of State,” please be advised that the Commission does not maintain records of other state agencies and you may wish to submit a request to the Secretary of State for such records.

In response to your third and fourth request, the Commission has conducted a diligent search of available records and has not located any records responsive to your request.

I am unable to find, on your websites, or by google search, any announcements of the appointments of the seven commissioners of the Commission on Legislative, Judicial and Executive Compensation, which, pursuant to budget statute [Part E, Chapter 60 of the Laws of 2015 \(§2.1\)](#), was required to have been established by June 1st.

Pursuant to FOIL (Public Officers Law, Article VI), §124 of the Chief Administrator's Rules, Senate Rule XIV, and Assembly Rule VIII, this is to request:

- 1.the commissions/writings appointing the commissioners and the filings thereof with the Secretary of State, required by [Public Officers Law §8](#);
- 2.the oaths of office taken by the commissioners – and the filings thereof with the Secretary of State, required by [Public Officers Law 10](#);
- 3.records of public announcements of the commissioner appointments, including on your websites and by notifications to the press;
- 4.records reflecting why the Commission on Legislative, Judicial and Executive Compensation has a non-governmental **.org** website, *to wit*, www.nyscommissiononcompensation.org, and a non-governmental [gmail.com](mailto:nyscompensation@gmail.com) e-mail address, *to wit*, nyscompensation@gmail.com.
