This follows up my March 15th e-mail to all members of the Senate and Assembly, whose subject line asked three questions: "Is the Judiciary Budget a 'Slush Fund'? What is its Dollar Cost – and that of the Appropriations Bill?"

Time is of the essence. Senate and Assembly leaders have announced their intention to have the Senate and Assembly vote on appropriations bills and a budget deal with the Governor by Thursday, March 21st. This means the bills must be on your desk today or tomorrow, absent the leaders' circumventing Article III, §14 of New York's Constitution by a "message of necessity" from the Governor. Yet, notwithstanding I sent out my e-mail before 9:00 a.m. on Friday, March 15th, I have received no answer to its subject line questions from any Senate or Assembly member, as of this hour and date, 9:00 a.m., Monday, March 18th.

Here's the paragraph that I just read to you over the phone, from page 10 of my March 11th letter, particularizing the information I'm seeking as to the cumulative dollar amount of the appropriations bill for the Judiciary – A3001. Please get me this information as soon as possible, as likewise the dollar amount requested by the Judiciary's budget – as to which the “Yellow Book”, “White Book”, “Blue Book” all give different numbers – with no number given by the “Green Book”.

“The Judiciary's ‘single budget bill’ also provides no cumulative tally of the appropriations it contains. Is the \$50,095,000 of ‘Reappropriations’ a sum on top of the ‘All Funds’, and ‘General State Charges’ – in which case isn't the total monies being appropriated \$2,683,991,476? Or does the bill contain more appropriations, as, for instance, \$15,000,000 for ‘New Appropriations (Supplemental)’ and \$51,000,000 for ‘Capital Projects-Reappropriations’, both tucked in the back.”

Subject: Judiciary Budget -- A Slush Fund as the Dollar Figures Would Show

TO: Lauren Paterno, Legislative Director to Assemblyman Buchwald

Following up our phone conversation a short time ago, attached is the letter I sent yesterday. Kindly read it and bring to Assemblyman Buchwald's attention IMMEDIATELY. It sums up much of what I stated to Chief of Staff Dan Weissfeld, when I met with him on Monday, March 4th, in the absence of Assemblyman Buchwald, who I understood was in Albany, hard at work on the budget – and with whom I spoke briefly, by phone, on February 15th, while en route to his office to drop off the documentary materials I had handed up when I testified before the Legislature, on February 6th, at its joint budget hearing on “Public Protection”. A copy of the note that I had written to the Assemblyman, when I dropped off the materials on February 15th, is annexed. The direct link to the video of the February 6th hearing with my testimony, posted on our website, is here: <http://www.judgewatch.org/web-pages/judicial-compensation/legislative-oversight-judicial-raises.htm>.

What I did not discuss with Dan on March 4th is what appears at pages 10-11 of the March 11th letter, identifying that the Judiciary has concealed the total dollar amount it is actually requesting for the Judiciary budget. It has also concealed

the total dollar amount of its “single budget bill”, embodied by the Governor’s appropriation bill—S2601; A3001. As stated at page 10, it appears to be “a veritable slush fund”.

Please get me these two figures by the end of the day – or as soon as possible.

I am most concerned that the documentary materials I dropped off on February 15th for Assemblyman Buchwald to review in substantiation of my February 6th testimony have not, as yet been reviewed by him – or perhaps by anyone else on his staff, etc. According to Alex Roithmayr , with whom I spoke before calling you, those materials are still in the district office – now moved to Mt. Kisco .

I had an excellent meeting on Friday, March 8th with Senator Latimer – with whom, additionally, I supplied a copy of those documentary materials. I suggest that Assemblyman Buchwald work together with Senator Latimer on this issue – a suggestion I discussed with both of them.
