Pursuant to Public Officers Law, Article VI [Freedom of Information Law (F.O.I.L.)] and Attorney General Schneiderman’s Project Sunlight Initiative of his Public Integrity Unit, this is to request all publicly-available records pertaining to:

EMILY PINES, DAVID DEMAREST, JEFFREY D. LEBOWITZ, STEPHEN FERRADINO, RALPH A. BONIELLO, III v. STATE OF NEW YORK- (filed in Supreme Court/Mineola, Nassau Co: #10-13518) - wherein Nassau Supreme Court Justice Karen V. Murphy held, in a February 9, 2011 decision, that the state is ‘obligated’ to pay judges a retroactive pay raise to April 2009.

Despite previous requests, you have not furnished ANY records of this case: either from Nassau Supreme Court or from the Appellate Division, Second Department (Docket#2011-2821), where the case is now pending on an appeal perfected by Attorney General Schneiderman on November 16, 2011.


